- **UNBENCHED OBEDIENCE TRIAL WILL NOT BEGIN BEFORE 12:00 PM**
- **JUMP HEIGHTS MUST BE SPECIFIED ON ENTRY FORM FOR ALL CLASSES REQUIRING JUMPS**
- **RUN ORDER WILL BE SMALL TO TALL**
- **TRANSFERS WILL BE ACCEPTED PRIOR TO THE TRIAL**

**GENERAL OBEDIENCE ENTRY RULES & INFORMATION**

- The term “dog” refers to either dog or bitch in both Obedience and Rally.
- Qualifying scores are required for all awards.
- Non-Regular classes are not eligible for the Special Obedience Trial trophies, nor will qualifying scores be awarded AKC legs or points towards Obedience Trial Championships.
- **OBEDIENCE MOVE-UPS & TRANSFERS WILL BE ACCEPTED ACCORDING TO AKC REGULATIONS.** Move Up/Transfer form must be submitted at the Trial Secretary's desk no later than 30 minutes prior to the start of the first class on the day of the trial.
- **Walk-Thrus** will be scheduled prior to Novice A / Preferred Novice / Beginner Novice A & B
- **AKC Refund Policy - Withdrawals** after the event's closing date and time due to a change of judge must receive a full refund (no fee is paid to the AKC).
- Females in season will be fully refunded with written confirmation from a veterinarian and submitted at the Trial Secretary's desk no later than 30 minutes prior to the start of the first class on the day of the trial.
- If Entries are limited, ISCC may accept entries of Irish Setters first, then accept entries from Group Breeds or All-Breeds until the Entry Limit specified in the Premium List is reached

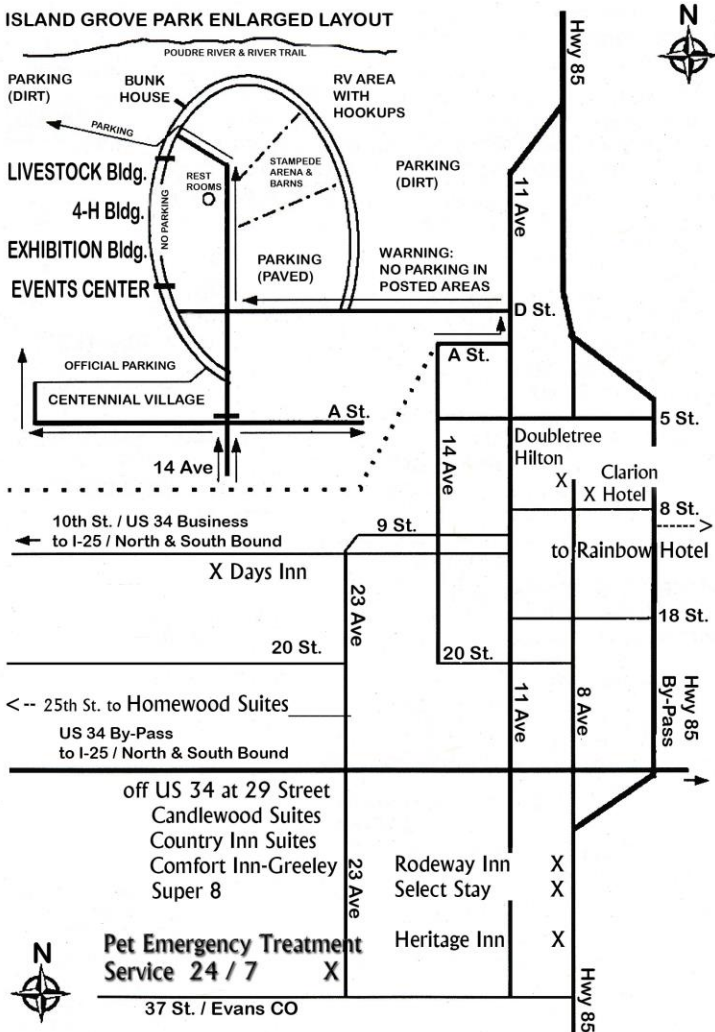

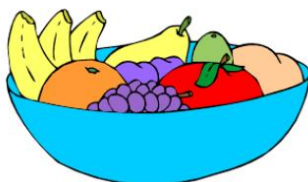

after which time no entries may be accepted, canceled, changed, substituted, corrected, or signed and no entry fees refunded. All changes and cancellations must be received in writing prior to closing, except as provided for in Chapter 11, Section 6 of the AKC Dog Show Rules.

**The Irish Setter Club of Colorado, The Greeley KC, and their Show**

**Secretary/Superintendent(s)** assume no responsibility for a wrong entry. Entries will not be accepted without proper fees and signatures. Entries must be submitted on approved entry forms with the agreement printed on the reverse side. Photocopies of front & back will be accepted if legible. Exhibitors are advised to print all unusual words when filling in entry forms.

**THIS SHOW** is governed by the American Kennel Club. Exhibitors should read the AKC agreement on the backside of the entry form in this Premium List.

**No entry fee will be refunded** for Bitches who come in season after the close of entries for this show, or for a dog that is absent, sick, lame, disqualified or excused by Veterinarian, Judge or Bench Show Committee. No entry fees will be returned if the show cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, strikes or any other causes beyond the control of the management. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The wellbeing of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made. **Note: Exhibitors** should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**RETURNED CHECKS** will be charged a \$30.00 collection fee. The returned check and fee must be paid with Cash at the Show Secretary's desk or office **BEFORE** the dog will be allowed in the ring.

**Dogs** need not be at the show until the scheduled time of judging. Dogs no longer needed for further judging will be excused. This show is unbenched.

**All dogs present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**The Clubs**, Island Grove Regional Park, Show Secretary/Superintendent, their Agents, employees, etc. assume no responsibility for injury to children or pets not under the control of their parents, handlers, owners or guardians.

**THIS IS A SELF-CLEANING SHOW.** A Bench Show Committee will be called on anyone not cleaning up after their dog or their grooming space and a minimum of \$250.00 fine will be assessed.

**Class cash prizes** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging is over, and the Show Secretary's office advised at once. The Show Secretary and show-giving Club disclaim any liability for cash prizes after the judging is over.

**RECORDING & EVENT FEES** include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.50 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes. There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes, or special attractions. (AKC Rule, Ch 11, Sec 2).
