  manner that contributes to the environmental pillar of sustainability while providing the
  framework for regulatory compliance.
- OHSAS 18001 specifies the requirement for an Occupational Health and Safety Management System that an organization can use to enhance its occupational health and safety performance. This standard is currently being replaced by ISO 45001 which takes into account the OHSAS 18001 requirements.
