The Board of Trustees met at the Hampshire Township Administration Offices at 170 Mill Ave., Hampshire, IL on the 14th day of November, 2024 at 7:00 pm.

1) The meeting opened with the pledge to the flag. There were no additions or changes to the agenda.

2) Minutes. The Board reviewed the Board of Trustee Minutes from November 14, 2024. A motion was made by Trustee Gustafson to approve the minutes as presented. Trustee Paddock seconded the motion and it was approved unanimously by all those present.

3) Treasurer's Report. The Board reviewed the November Treasurer's report. A motion was made by Trustee Drendel to approve the November Treasurer's report as presented. Trustee Paddock seconded the motion and it was approved by all those present. A roll call vote was taken. #### 5) Reports

Assessor: Assessor Penkaty reported that she attended the assessor meeting with the supervisor of assessments in Geneva. This upcoming Friday, the assessors will be getting together for their monthly meeting/Christmas party. For the month of November, there were 32 sales. 19 were for new construction, 10 were existing residential, 1 was residential land, 1 was farm, and 1 was for the new company that purchased the existing rental townhomes. She is keeping busy with measuring, taking pictures, and working on new permits.

Highway Commissioner: Highway Commissioner Rowlett reported that they had the trucks checked. The new pick up truck was taken to Huntley Ford for a service recall. They picked up some new sign posts in Bartlett. Mr. Rowlett met with Vic from Peter Baker to discuss next year's road projects. They are Lenshow and Romke Roads (to Berner Road). They put new lights on the bus garage that are adjustable and placed the old ones on the road garage. There was some wood debris that they had to pick up on Brier Hill Road. The plows were put on the trucks on 11/19. On 11/21, they went out and salted the roads as we had received about an inch and half of snow. On 11/22, Mr. Rowlett and Mrs. Remakel had a phone meeting with Jodie from the Kane County Department of Environmental and Water Resources regarding the intergovernmental agreement.

Supervisor: Supervisor Remakel reported that the Pace report came back and they didn't like some of the answers. She is getting no help with correcting it. The Transit was delivered to the dealership with no seats. The check has been issued and is sitting on her desk for when the vehicle is ready. There is new software for the Seniors to sign up for events. She is working on the customization for our needs. It is called SchedulePlus and it has the ability to handle not only Senior registration, but building rentals and the medical lending closet. Mrs. Remakel reported on the issue with the new bathroom. An alarm was

Commission Rowlett indicated she did change the wording and it was reviewed by the Board to their acceptance. There being no further discussion, Supervisor Remakel made a motion to approve the Intergovernmental Agreement with Kane County. Trustee Paddock seconded the motion and it was approved unanimously by all those present. A roll call vote was taken.
