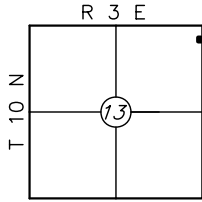


# BOUNDARY SURVEY

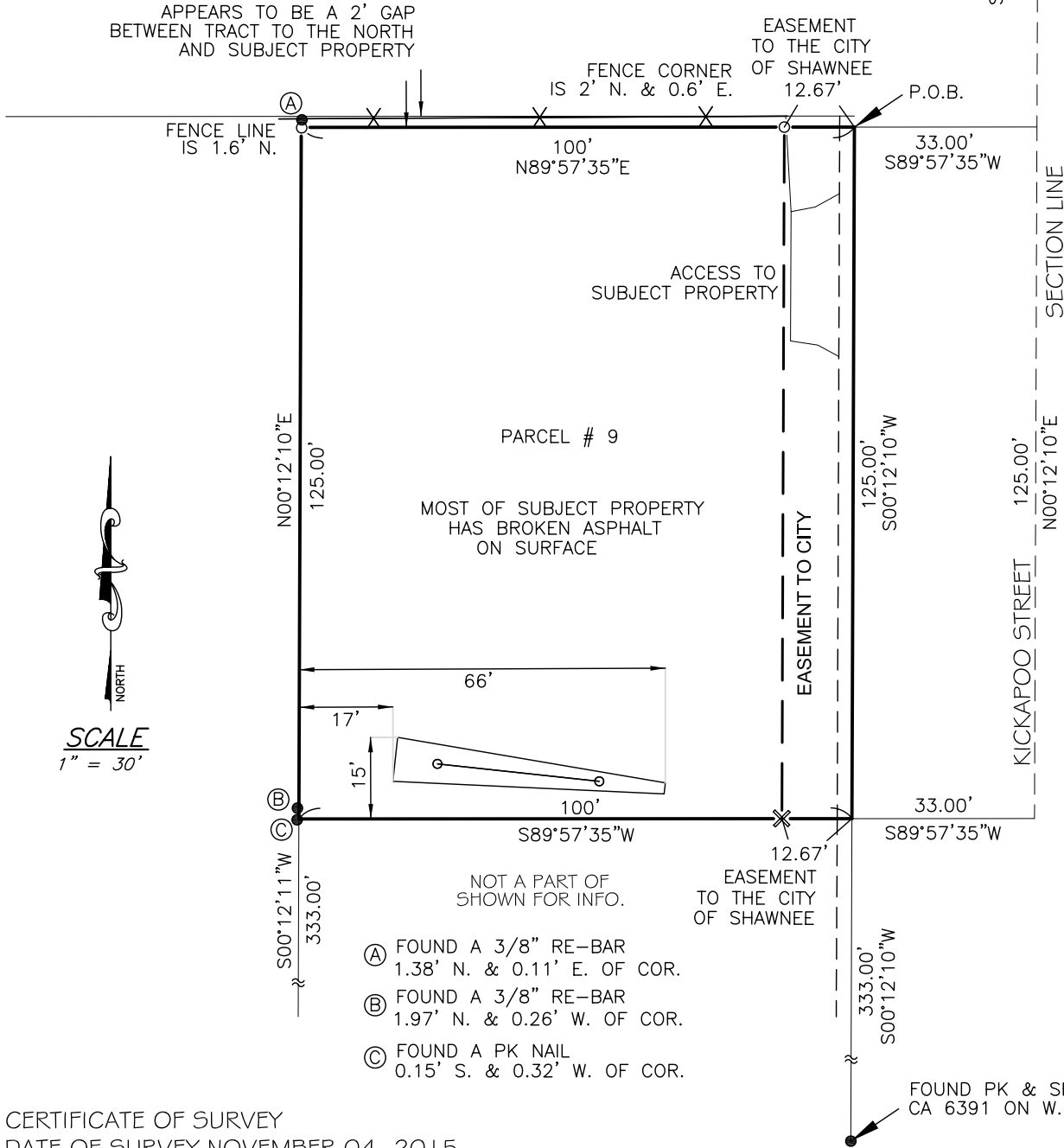


LOCATION MAP

### LEGAL DESCRIPTION

A TRACT OF LAND BEGINNING 365 FEET SOUTH AND 33 FEET WEST OF THE NORTHEAST CORNER (NE/c) OF SECTION THIRTEEN (13), TOWNSHIP TEN (10) NORTH, RANGE THREE (3) EAST OF THE INDIAN MERIDIAN, POTTAWATOMIE COUNTY, OKLAHOMA; THENCE SOUTH 125 FEET; THENCE WEST 100 FEET; THENCE NORTH 125 FEET; THENCE EAST 100 FEET TO THE POINT OF BEGINNING. CONTAINING 12500 SQUARE FEET, OR 0.29 ACRES, MORE OR LESS. HAVING A ASSUMED BASIS OF BEARING OF S00°12'10"W, BASE LINE BEING THE EAST LINE OF SAID SECTION 13.
