"Humbly asked Him to remove our shortcomings."

She said: Recently I saw an ad that really struck a chord with me. It portrayed a variety of people in situations that really freaked them out and their subsequent reactions of discomfort, ranging from short-circuit to implosion. Suddenly, just as their level of suffering was most acute, a large red "easy button" appeared. The person hit the "easy button" and instantly everything was fine. The practice of Step Seven is my easy button. Not because it is easy, nor because it leads to the aversion of crisis or pain, but because the humility it entails sets me free by changing my perspective. As Teddy Roosevelt wrote, "Pray not for lighter burdens, but for stronger backs!" When I humbly ask my Higher Power to remove my shortcomings I recognize that I don't need to freak, because God's got my back. And on some level that it is not my business to understand, all is fundamentally well with me and the universe.

The mechanism for strengthening my proverbial back is the spiritual vehicle of acceptance. This requires willingness to exercise surrender instead of trotting out the dynamic duo of self-will, paralysis or manipulation. The activator of all my character defects is fear, and my reaction to this fear is characteristically "all or nothing" ambitious tension.

The idea that it is up to me to control what happens as well as my attendant emotional state, prompts me to attempt to play God. Without the easy button of humility, it does not take long for my ego to work me into a frenzy of reactive defense, or when I suspect that "will not work", to sit alone at the bottom of a pit of despair, flailing in a sea of worry or bitterness.

**Step Seven is** a process of unlearning in which we let go of our programming and attachment to reshaping reality or ourselves to our distorted vision. When we stop listening for confirmation of what we already think, we become able to let go of judgment and comparison. I was taught that when I'm on emotional fire I have a tool to use. *(continued p. 2)* 

He said: Ahhh, here we are one month later...And how wonderful it has been to

take a deeper look at Steps Six and Seven. When I started this column I did not fully know their joys and rewards. Now, with some pain and much joy behind me, I think I 'kinda' get them. Now I know why Bill says in the 12 and 12, "This is the Step that separates the men from the boys in AA."

**Six and Seven** are about changing; changing from the people we were into the people that God wants us to be. There *is* work involved; work and the joy that comes with overcoming longstanding obstacles. For me this all goes to show that we learn by being of service. If I hadn't said I would do this column I wouldn't know these things. If ever you are asked to write a column for the GIS you should definitely say yes. In fact, when AA asks the answer is....? What was that? Maybe? NO! The answer is YES.

If Step Six is all about identifying our defects and becoming willing to let go of them all, Step Seven is about humbly asking to have them removed. Much of the work then is in Step Six. There we identify our defects, shine light on them and put them on the chopping block. We have developed awareness of our faults and accountability for them. So how do we work the Seventh Step? Well, first we do a good Sixth Step. From that we have an inventory of our defects and shortcomings. For each defect we humbly pray to God to have it removed. In the Big Book there is a great Seventh Step Prayer. It goes, My Creator, I am willing that You should have all of me, good and bad. I pray that You now remove from me every single defect of character which stands in the way of my usefulness to You and my fellows. Grant me strength, as I go out from here to do Your bidding.

What stands out to me is that this prayer is asking God to remove the defects that stand in the way of usefulness to our fellows and to God, NOT the defects of usefulness to our ego, (continued p. 2)

(She Said cont.) It is the same tool to use in case of a fire in the material world, namely," stop, drop, and roll". This means to stop, "pause when agitated or doubtful", drop, get on my knees either literally or figuratively, and ask HP for a hand, and roll, do the next right thing and don't tangle the net by energetically writhing. This moves me out of the realm of conditioning and into the realm of humility, the acceptance of being human. It allows me to step off the goodness treadmill and to separate my essence from my disease. I am cracked, but I am a sacred vessel anyway. Therese of Lisieux observed, "Genuine holiness is precisely a matter of enduring our own imperfections patiently."

Does this mean we sit around waiting to be "poofed"? Nope. "We surely must try...or else fall by the wayside". For me the answer resides in an attitude of faith, looking with love instead of judgment. I accept that I see the world not as it is, but as I am. When I understand that falling down is the nature of the game I learn that I continue to be helpful to others when I laugh at myself instead of fight with myself. In fact, the words human, humor, and humility, share the same root. While I am responsible for the effort, I have nothing to do with the outcome. I can't get rid of my shortcomings and I can't make myself humble. I can use the experience of my imperfections to convert shame and disappointment to hope for my fellows. Accepting personal shortcomings and cultivating a healthy selflove helps us to accept the imperfections in others as well. "Honesty gets us sober" Bill once wrote, "but tolerance keeps us sober".

(He Said cont.) or even the ones WE want to have removed....This tells me that God gets to pick what stays and what goes and when. God may use one of my defects for some purpose, and my defects may never disappear completely. My defects keep me from being perfect, if I was perfect I would not need AA, I would not need a solution, I would be the solution. So in a way, my defects and shortcomings keep me coming towards God. What a nice way to think about it. This prayer also says GOOD and bad. This begs the possibility of an assets inventory, step six-and-a-half. I know some sponsors have their sponsees do it. It is great to use the same tools we use to pluck out the 'bad' to highlight the 'good', what it is that we do well so that we can do more of it. Maximize the good minimize the bad.

Humility is the thing that gets discussed the most with Step Seven. We Humbly asked. I don't really know anything about humility. Not much anyway. I did read that humility is an active surrender and I like that. It sounds right. I do think humility and acceptance are the same thing. Gratitude as well, it's the same thing; an embrace of this perfect God moment for exactly what it is. All of the mind chatter silenced in the glory of the great moment.

They are quite at liberty to accept advice or even direction from anyone at all. They can simply refrain from using their absolute legal right to say "no" when it would be much wiser, all things considered, to say Just as the conference should avoid the overuse of its traditional authority, so should the Trustees avoid overuse of their legal rights.
