

An Ordinance to prescribe limits within which  
no building shall be constructed except of  
brick, stone or other incombustible material

Be it ordained by the Mayor and  
Council <sup>of</sup> the City of Garnett.

Section 1 That it shall be unlawful for any  
person to build construct or erect any  
building of wood or other combustible  
material or any house or building of any  
kind except <sup>it be</sup> of brick stone or other  
incombustible material. Constructed  
within the following limits and upon the  
following lots and blocks in the City of  
Garnett to wit Lots (Twenty one) (Twenty two)  
(Twenty three) and (Twenty four) in Block (Thirty four)  
and Lots (Thirteen) (Fourteen) (Fifteen) (Sixteen)  
(Seventeen) (Eighteen) (Nineteen) (Twenty)  
(Twenty one) (Twenty two) (Twenty three) and (Twenty four)  
in Block (Thirty five) and Lots (One) (Two) (Three)  
(Four) (Five) (Six) (Seven) (Eight) (Nine) (Ten)  
(Eleven) (Twelve) (Thirteen) (Fourteen) (Fifteen)  
(Sixteen) (Seventeen) (Eighteen) (Nineteen)  
(Twenty) (Twenty one) (Twenty two) (Twenty three)  
and (Twenty four) in Block (Forty six) and  
Lots (One) (Two) (Three) (Four) (Five) (Six) (Seven)  
(Eight) (Nine) (Ten) (Eleven) (Twelve) (Thirteen)  
(Fourteen) (Fifteen) (Sixteen) (Seventeen)  
(Eighteen) (Nineteen) (Twenty) (Twenty one)  
(Twenty two) (Twenty three) and (Twenty four) in  
Block (Fifty five) and Lots (One) (Two) (Three)  
(Four) (Five) and (Six) in Block (Forty seven) and  
Lots (Nineteen) (Twenty) (Twenty one) (Twenty two)  
(Twenty three) and (Twenty four) in Block (Forty seven)

1 and Lots (one) (Two) (Three) (Four) (Five) and (Six)  
2 in Block (Fifty four) and Lots (nineteen)  
3 (Twenty) (Twenty one) (Twenty two) (Twenty three)  
4 and (Twenty four) in Block (Fifty four)  
5 and Lots (Six) (Seven) (Eight) (nine) (Ten)  
6 (Eleven) and (Twelve) in Block (Fifty six)  
7 and the above described Lots and Blocks  
8 and all Streets and Alleys contained in  
9 and separating the same shall be and is  
10 the Fire limit in said City of Garnett  
11 Section 2 Any person violating the  
12 provisions of this ordinance shall  
13 be guilty of a misdemeanor and fined  
14 in a sum not to exceed one hundred  
15 dollars, and any building hereafter built  
16 constructed or erected in violation of  
17 this ordinance on any of the Lots or blocks  
18 as described herein or within said fire  
19 limit shall be deemed and held a public  
20 nuisance and abated and removed by the  
21 City Marshall on order of the Police Judge  
22 Provided however this ordinance shall not  
23 be so construed as to prohibit the construction  
24 of wooden or frame Privies within the above  
25 described limits

26 Section 3 This ordinance shall take effect  
27 and be in force from and after its publication  
28 in the Garnett Plaindealer
