

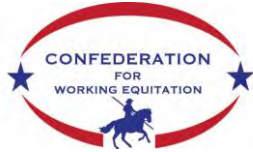

BIOSECURITY MEASURES:

- **ALL HORSES MUST BE INSPECTED BY KITTY MCLAUGHLIN UPON ARRIVAL. ANY SIGNS OF VS WILL RESULT IN THE HORSE BEING REMOVED IMMEDIATELY FROM THE PROPERTY**
- **ALL HORSES MUST REMAIN SECURED TO THEIR TRAILER WHEN NOT BEING RIDDEN. DO NOT TIE THEM TO PANELS OR RAILS IN THE ARENA.**
- **NO CONTACT BETWEEN HORSES**
- **RIDERS MUST USE THEIR OWN EQUIPMENT FOR THE COMFORT AND CARE OF THEIR HORSES. DO NOT SHARE BUCKETS, HAY NETS, BRUSHES, ETC**
- **PLEASE SPRAY HORSE AND TRAILER BEFORE LEAVING HOME BARN, UPON ARRIVAL AT CIRCLE STAR ARENA AND AGAIN BEFORE LEAVING TO HELP CURTAIL THE SPREAD OF VS.**
