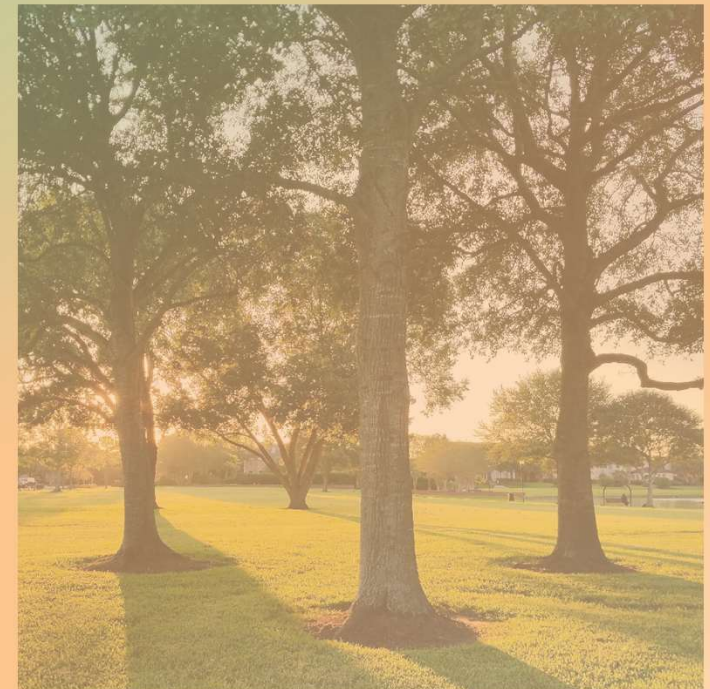

❖ Understanding How Our Associations Work - JOHN FISHER

Our community is made up of **legally separate homeowners associations**:

- Southwyck Master HOA (Master Association)
- Section HOAs (Section 1, Section 4, and Section 5)

Each one is its own legal entity with its own board, own budget, own reserves, and its own financial and maintenance responsibilities.

What Section HOAs Do

- Maintain and manage their own property, according to their own governing documents.
- Create and approve their own budget, own reserve plans, and own assessments value.
- Are responsible for funding their own maintenance, repairs, and reserves.
- Approve Architectural Committee (ARC) requests and send out violation notices to homeowners.

Where the confusion usually happens

Some homeowners believe that because the Master HOA collects all assessments at once, the Master can also use its funds to cover Section HOA expenses.

Our governing documents do not allow this.

Why funds cannot be shared or transferred

1. Different corporations

Each HOA is a separate legal entity - similar to separate companies. One entity's money cannot be used to fund another entity's operations.

2. Restricted funds

Master assessments must be used only for Master HOA obligations. Section assessments must be used only for Section obligations.

3. Fiduciary duty

The Master Board has a legal duty to protect Master funds for Master property — not to subsidize another corporation's shortfalls.

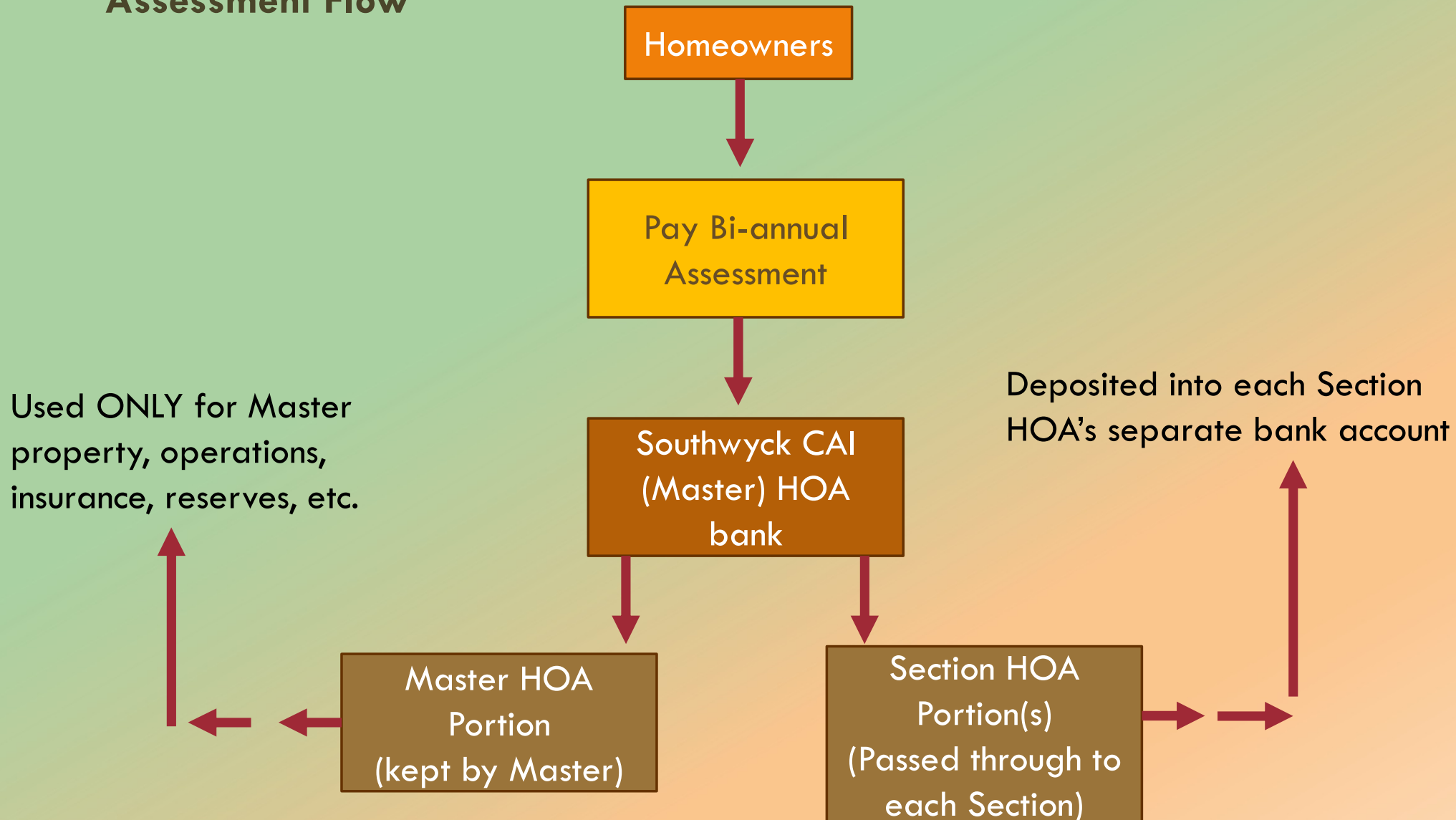
4. IRS and state compliance

Mixing funds between separate 501(c)(3) or nonprofit entities can create serious compliance and tax issues.

❖ Master and boards' responsibilities – RICK NELSON

- **Collection of assessments.** Distribution of each section's portion of the assessments and retain the Master's assessment portion.
Sections and the Master set their own assessment amount each year. Interest on the section's late payments is given to the appropriate section.
- Come up with a **yearly budget** for our expenses and reserve contributions.
- **Landscape maintenance**, including but not limited to mowing, edging, blowing, plantings, mulching, pest control, irrigation system, and watering of 18 entrances and 2 parks.
- All costs associated with the **lighting and irrigation** for all 18 **entrances** and our 2 **parks**.
- **Tree trimming.**
- Repair/replacement of all **perimeter fences** along a major road.

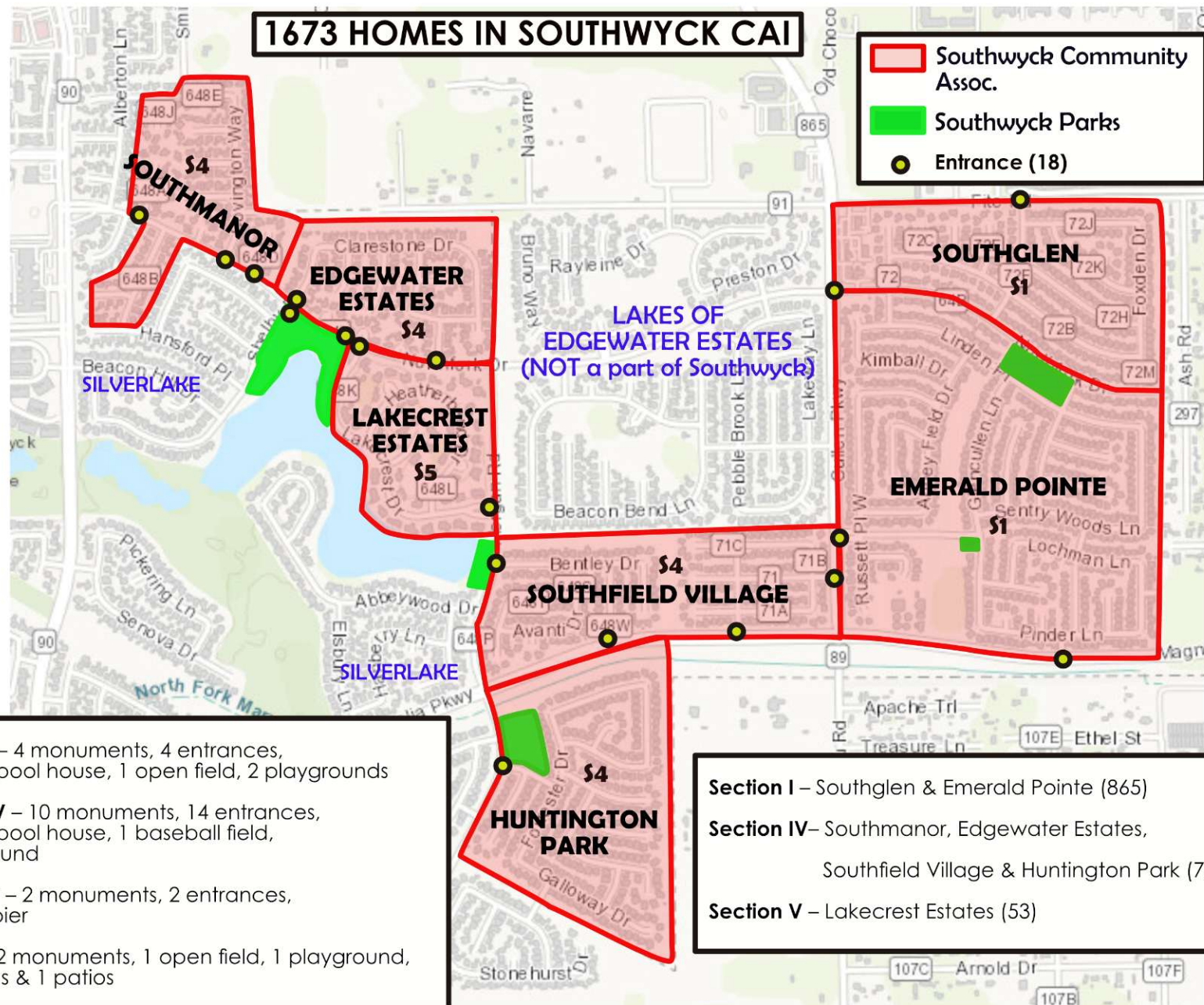

❖ **Master and boards' responsibilities (continued) – RICK NELSON**

- **Park equipment** including play structures, sunshades, picnic tables, benches, swings, water fountains & foot washing station, volleyball court, sand box, sidewalks, trash cans and doggy stations in our 2 parks.
- Upkeep of the **lake, fountains and bulkhead** - cost sharing with Silverlake for lake chemicals and fountains only.
- Maintenance of **covered structures** and the 2 **patio structures** at our 2 parks.
- **Power washing** of entrances, fences, play equipment, patios/pavilions and graffiti removal.
- **Casualty insurance** for master and sections at no charge to sections.
- Directors and officer's **liability insurance** for the master board.

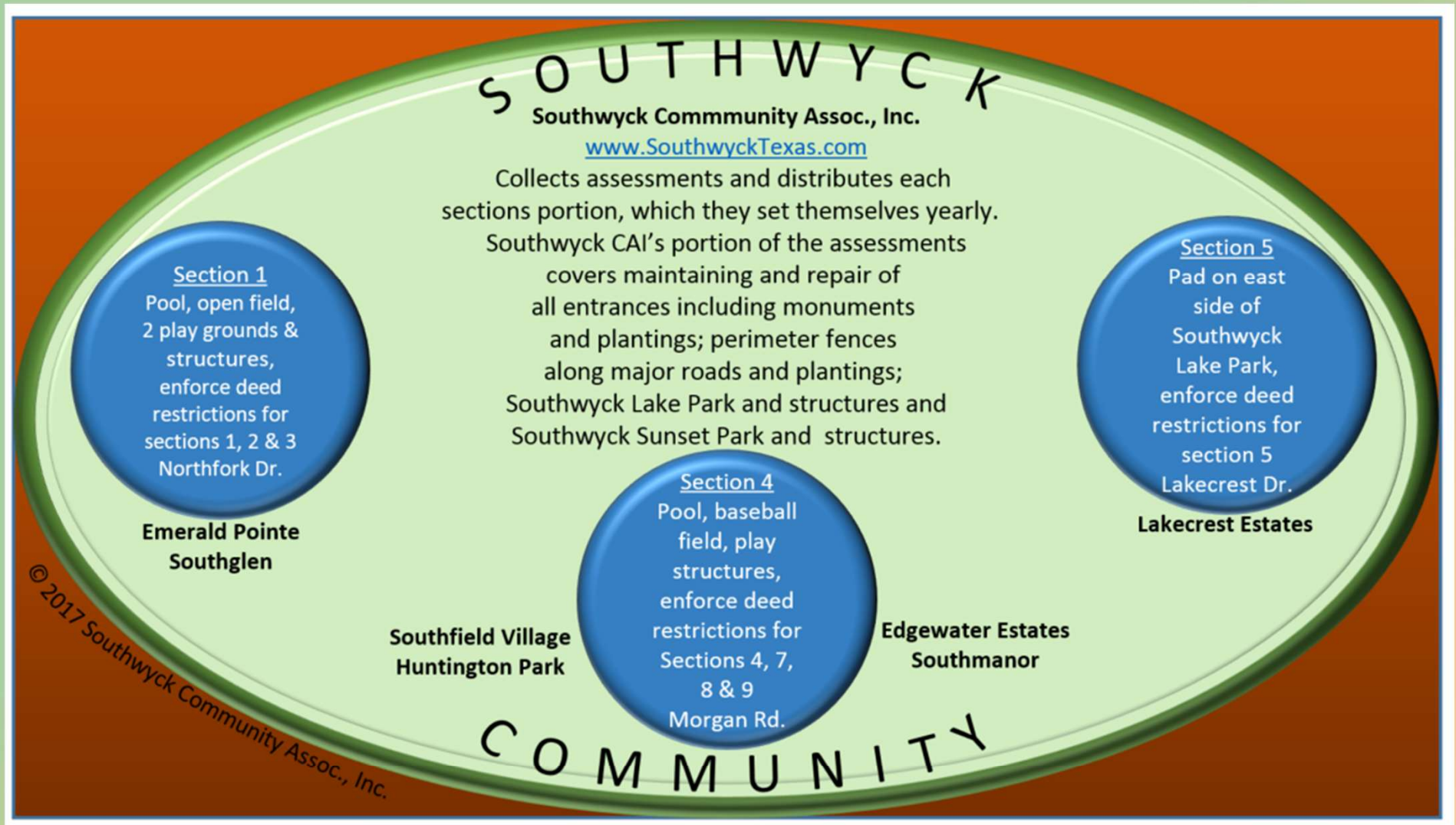

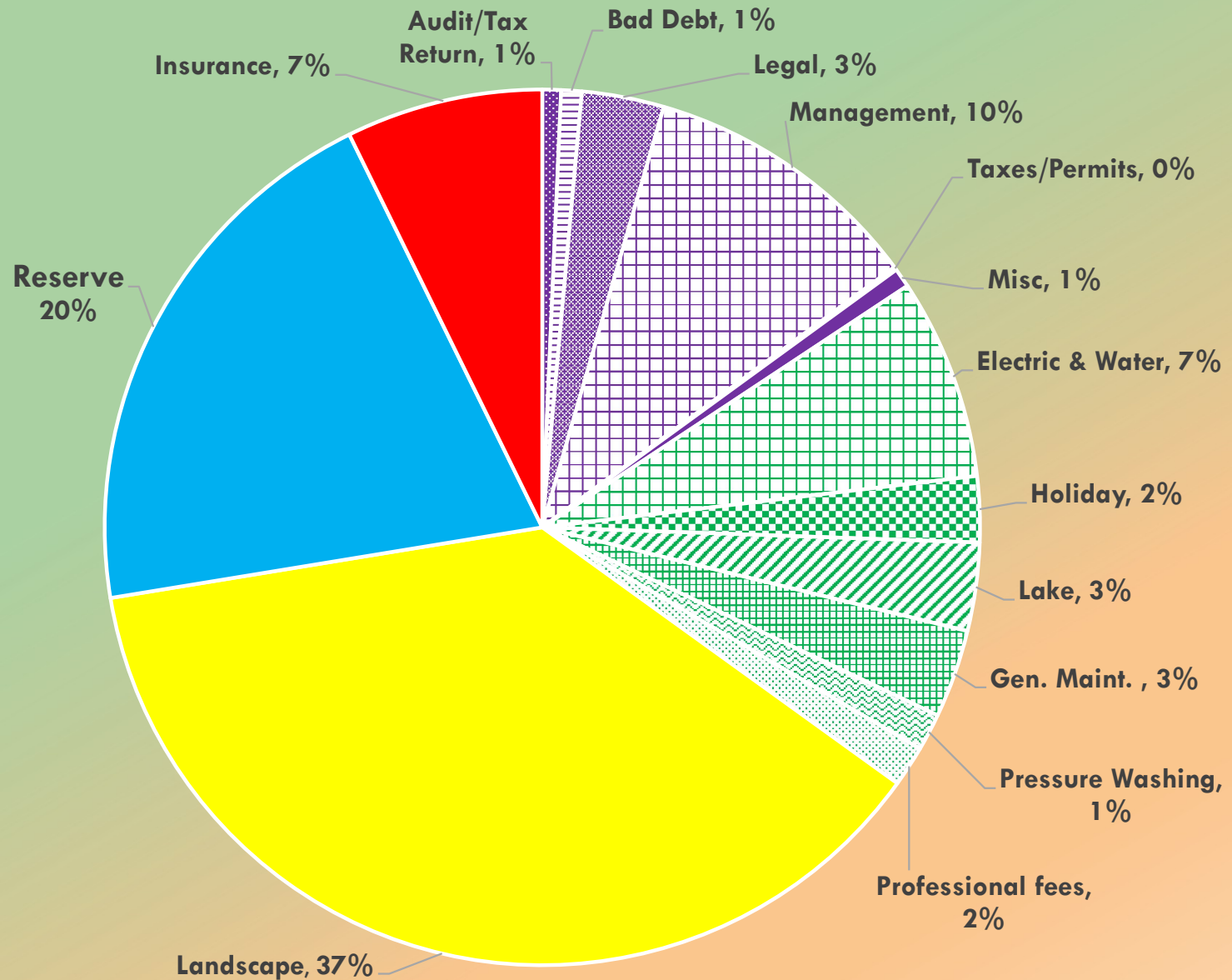
(Not listed by priority)
