The Stratton School Board held its monthly meeting on Thursday, March 1, 2018 at the Stratton town office. The meeting was called to order at 7:12 p.m.

NO MODIFICATIONS TO AGENDA

NEW BUSINESS:

Ms. Webber Bennett attended the meeting for the purpose of asking the Board questions regarding Article #6 of the Annual School District Warning. She questioned her son's continued attendance to Long Trail School. Chairman Montemagni explained the aspects of the budget, funding of tuition and high schools where students attend. Ms. Bennett was encouraged to attend Stratton's town meeting where all aspects of the Warning would be addressed and voted on by Stratton town residents.

MINUTES: Minutes from the February 1, 2018 meeting were read. Lorraine Weeks Newell motioned to approve and Thomas Montemagni seconded.

NO RESIDENCY APPLICATIONS

CONTINUED BUSINESS:

As reported in the February 1, 2018 minutes, the Stratton School Board intended to revise Stratton's School District Residency Policy F13 and Tuition Payment Policy F16.

Siobhan Eddy Young motioned to approve the Stratton Tuition Payment Policy F16, as defined by 16 V.S.A 823 and 824. Lorraine Weeks Newell seconded.

Siobhan Eddy Young motioned to approve the Verification of Stratton Residency Policy F13, as defined by 16 V.S.A 1075. Thomas Montemagni seconded.

Policies F16 and F13 were approved.

In September, the Board will readdress the policies governing school attendance, residency and tuition.

There has not been any new information regarding a potential meeting. Superintendent Anton will contact Ms. Holcombe's office later this month for an update on scheduling the meeting.

The following bill was not included in the order from 2/1/18.


Twin Valley Middle School District – Tuition Stipend - \$500.00 CK#4399
