Treasurer's Report:

Treasurer Jayne O'Brien noted the following. The General Fund started with a balance of \$1,114.02, with deposits of \$500.00 and expenses of \$19.77 (Staples) leaving a balance of \$1,594.25. The Grant Fund, Athletic Hall of Fame, and the Scholarship Fund had no activity, leaving balances of \$3,809.98 (Grant Fund), \$7,458.34 (Athletic Hall of Fame) and \$16,891.37 (Scholarship Fund). Total balance in Washington Trust Account is \$29,753.94. The report was accepted on a motion by Sal Masiello, seconded by Lyle Perra.

Scholarship Committee:

Chairman Paul Dolan reported that the association had received eight applicants for scholarships. The committee recommended five of the applicants receive scholarships. Discussion was had regarding how the scholarships would be dispersed, either in one \$1,000 check after verification or into two \$500 checks (one per semester). On a motion by Sal Masiello, seconded by Lyle Perra it was decided that a single \$1,000 scholarship would be awarded to the five recommended applicants. Each would be a named scholarship.
