AN ORDINANCE OF THE VILLAGE OF INNSBROOK, MISSOURI, SETTING THE FILING DATES, TIME AND PLACE FOR THE GENERAL MUNICIPAL ELECTION TO BE HELD ON APRIL 7, 2026, IN THE VILLAGE OF INNSBROOK, MISSOURI

**WHEREAS**, a general municipal election is to be held in the Village of Innsbrook, Missouri, on Tuesday, April 7, 2026; and

WHEREAS, at this election, two (2) Members of the Board of Trustees will be elected.

## NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, MISSOURI, AS FOLLOWS:

- **SECTION 1.** The 2026 general municipal election shall be held on April 7, 2026. Any person desiring to seek election to any elective Village office at the 2026 general municipal election may do so by filing his/her candidacy with the Clerk of the Village of Innsbrook at the Village Hall located at 13600 State Highway M, Innsbrook, Missouri, 63390, during regular office hours from 10:00 a.m. to 2:00 p.m. during the following period: December 9, 2025, through December 30, 2025. The Village Clerk shall receive all candidates, during regular office hours, in the order in which they appear, until filing closes.
- **SECTION 2.** Any person who is not qualified for office as provided by state law or Village Ordinances shall not be entitled to have his/her name printed on the ballot. No person shall be elected or appointed and sworn into office who is not qualified for such office as provided by State law or Village Ordinances.
- **SECTION 3.** The 2026 general municipal election shall be conducted as described and set forth in the Comprehensive Election Act of 1977, as amended.
- **SECTION 4.** The Village Clerk is hereby directed to cause public notice to be given of the general municipal election in accordance with the requirements of Section 115.127, RSMo. The notice of opening and closing of filing to be published shall be as set forth in **Exhibit A**, attached hereto and incorporated by reference herein.
- **SECTION 5.** The Village Clerk shall notify the Director of Elections, as the designated election authority, in writing, that the Village is calling the general municipal election, specifying the purpose of the election, and the date of the election, the legal notice to be published and the sample ballot. The Director of Elections shall conduct the Village general municipal election in accordance with State laws.
- **SECTION 6.** Savings Clause: Except as expressly set forth herein, nothing contained in this Ordinance shall in any manner be deemed or construed to alter, modify, supersede, supplant

or otherwise nullify any other Ordinance of the Village or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof.

SECTION 7. Severability Clause: If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the Board of Trustees that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the Village and shall thereafter be binding.

**SECTION 8**. Effective Date: This Ordinance shall be in full force and take effect from and after its final passage and approval.
