Moving Forwards

After 9 months (The Lion's Den) and the artist will meet to review experiences shared over 9 months and discuss the possibility of entering into a 12-month contract. The possibility of signing to (The Lion's Den) and renewing the 6 month contract may also be discussed.



(The Lion's Den) Terms of Agreement

This is to confirm our agreement for the development plan where you as the Recording Artist and we as an Artist Development Company agree to the following:

- 1. TERRITORY** World.
- 2. TERM** The term of this agreement shall be for an initial period of 3 months, and a potential further 6 months should both parties see it fit to extend the initial agreement.
- 3. RECORDING**
 - 3.1 Times, dates and durations for recording should be agreed upon at least 72 hours before recording.
 - 3.2 We agree to use all reasonable endeavors to ensure that all recording equipment necessary is available to you within the requested period of time.
 - 3.3 We undertake to ensure that the recording studio will provide you, at the end of the recording and production period, a complete master in which will include the production after mixing and mastering processes.
- 4. COPYRIGHT**
 - 4.1 Producers and writers who worked on the product will be credited as producers and writers accordingly.
 - 4.2 The split between the rights of the music and the lyrics will be according to the contribution of the artist and the producer in the process of writing. The split will occur after the final product has generated more than £100.
 - 4.3 Products distributed digitally will be published under (The Lion's Den) publishing with (The Lion's Den) having the rights to upload and distribute the product through the agreed platforms.
 - 4.4 You grant your permission to us to exploit the master recordings and the underlying original compositions on a non-exclusive basis.
 - 4.5 The Artist will be entitled to a standard 10% Royalty from sales directly generated by (The Lion's Den).



5. EXPLOITATION

- 5.1 In order to exploit your music and bring you and your music to the knowledge of the public we will upload the final product to all the main digital outlets, including: iTunes, Amazon and Spotify in the form of an album or EP should you wish to receive digital distribution.
- 5.2 After collecting data and information such as sales reports from digital outlets this information will be shared with you quarterly upon request.
- 5.3 You give us the right to upload and most materials and news about you as part of a promotional campaign.

6.0 PAYMENT

- 6.1 Services provided by (The Lion's Den) will not be charged as an additional expense or be deductible from any profits made throughout the agreed period.
- 6.2 Digital distribution is currently a free service provided at no extra additional cost. Should circumstances change with our partners and digital retailers and we can no longer provide this service free of charge we will make you aware of this beforehand and discuss how best to proceed accordingly.
- 6.3 Artists are expected to pay deposits before services occur. Outstanding balances can be paid through a negotiated payment plan.
- 6.4 All payments made to (The Lion's Den) are non-refundable.

7. STRUCTURE

- 7.1 An action plan should be agreed in accordance with the agreed time period. The Artist and (The Lion's Den) should agree what they would like to achieve in this time period and develop a realistic schedule accordingly.
- 7.2 (The Lion's Den) has an obligation to be providing one of the services mentioned at any given time. Multiple services running concurrently can take place but there is no obligation to do so. The expected response time for any one action by (The Lion's Den) as part of a service should be one week.



8. CONDUCT

- 8.1 The Artist warrants that he/she will not allow any illegal drugs or alcohol into the studio or illegal activities to occur in the studio.
- 8.2 The Artist warrants that he/she will not allow the creation of any illegal, infringing, or defamatory recordings in the studio.
- 8.3 Products created will be reflective of the gospel genre.
- 8.4 The Company reserves the right to suspend this agreement for the maximum duration of three to six months if the company's normal business operations are delayed or become impossible or commercially impractical from the following reasons: Act of God, fire, catastrophe, labour disagreement, acts of government, its agencies or officers, regulation, delays in the delivery of materials and supplies, or any other cause beyond the companies control.

9. TERMINATION

- 9.1 This agreement may not be modified or cancelled except by mutual consent, in writing and signed by you and us unless terms or codes of conduct are breached.
- 9.2 The termination of the agreement does not release us and you from the obligation to pay for the profits or services made during the term.
