Our youth come from neighborhoods throughout San Francisco and from all manner of schools, churches, soccer clubs, friends' networks, and sports programs. We have found common ground on the soccer pitch. This Association shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not permitted to be carried on by a corporation exempt from federal income taxation.
