**AN ORDINANCE AMENDING ORDINANCE NO. 2006-4 ENTITLED
"AN ORDINANCE ESTABLISHING A VOLUNTEER RESCUE SQUAD
FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS" AS AMENDED**

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

Section 1: Ordinance No. 2006-4, as previously amended by Ordinance No. 2010-6, is amended by deleting paragraph a of Section 1 in its entirety and replacing it with the following new paragraph a of Section 1:

- a. The rescue squad shall be made up of volunteers who will donate their time and skills to the Village. Notwithstanding the foregoing, and except as may be prohibited by law, volunteers shall be compensated for calls they respond to as follows: \$10.00 per call for emergency medical responders, \$15.00 per call for emergency medical technician – basics and \$20.00 per call for emergency medical technician – paramedics/prehospital RN's. All standbys and approved training/station duties will be paid at a flat rate of \$15.00 regardless of level. All members of the rescue squad shall be appointed by the Village President with the advice and consent of the Board of Trustees.

Section 2: This ordinance shall be in full force and effect upon its passage and approval as provided by law.
