LLVs & POVs!

deadline! Some areas of the state have more LLVs than POVs and some areas have more POVs. I, personally, have never driven an LLV but I can see where that loading and delivering out of a LLV would be less restrictive than a POV. The LLVs have the mail tray that will load 3 trays of mail side by side and a large cargo area for packages and residual mail. Now a carrier that drives a POV on a route has quite a few decisions to make before attempting to load their vehicle. First of all what type and style vehicle is it? How should they pull their mail down and tray, strap or tub it for delivery? Where will certain mail be placed in the vehicle so that the carrier can safely sit in said vehicle and deliver the mail? Where will all those parcels fit? Where will they put accountable mail? Where will they put money box and stamps? Where will they put residual mail for later part of route? Where will they put circulars so they can be worked with other mail? So you see a carrier that delivers in a POV has many decisions to solve even before they pull down their mail. Now if a carrier has been delivering a route which has a LLV assigned and then has to cross over to a POV route they should have some extra training with the POV carrier, wouldn't you think? They just don't get it.

After traveling much of the state visiting different Districts, I was looking for the results of the District Officer training from February and was pleased to see there were positive reflections at each District. There were a few areas that still need some tweaking which was noted for future reference to training. Over all the meetings went very well and stayed on track. The Presidents kept the meetings running right along and the Secretaries reports were, for the most, representative of the District's finances and past business. Delegates elected to serve your District need to be prepared to do the business of the Association from June 29 to July 1, 2015 in Macon, GA at the Macon Marriott City Center. This is what the scanner weighs. I carry my scanner in the black nylon pouch we were issued. I attach this to my belt when I depart for the route. It stays there till I get to my last delivery. Where I go, it goes.

You're probably wondering at this point about my issue with this. It's causing my SHIRT to become UN-TUCKED multiple times each day! This is very bothersome to me. I don't have any extra time each day to deal with this but I do. I try to do a quick tuck method as I'm returning to my LLV. This is a temporary fix till I can do it right. I hope my customers haven't witnessed this method. They probably wouldn't understand what they are seeing. (I hope I never wind up on You Tube!) Fortunately I have places on my route I can take care of my issue A while back I was having my issue towards the end of the route. I had a parcel that had to be delivered to the customer's door. Due to safety concerns I do not park the LLV on the road when I have to make a delivery to this customer's door. It's located in a blind curve with heavy traffic. I

make a SAFE, SLOW 3 point turn at the residence BEFORE making a safe dismount. Everyone knows what a safe dismount is RIGHT? Roll away, Run away accidents are avoidable. I went to the door, set the parcel down and scanned it delivered. On the way back I figured it would be a good time to properly take care of my issue. About halfway through the process a voice called out 'Thank you!' Busted! Didn't think anyone was home. 'Your welcome' I answered as I finished the process never slowing down or looking back. Always perform your job as if you are being watched. You never know when someone's looking. If you ever find yourself in a potentially embarrassing situation be professional and polite. Service with a smile and a good laugh occasionally!

State Delegates

The elections for state delegates are now over with. If you were elected to serve your district as a state delegate at the 2015 Convention in Macon, GA. and know that you won't be able to attend; please let your district Secretary know as soon as possible. National Ballots

The last day that nominations will be accepted for a place on the national ballot is May 20th. The drawing for the placement of names on the ballot will be held that evening. Contact me for the location and time if you would like to observe. Ballots will be mailed on or before June 9th. You normally have about two weeks to mark and mail your ballot, but with the

Postal Services' delay in processing you will need to vote your ballot and return it immediately. The voted ballot must be received by June 27th to be counted.

Each year approximately 4900 ballots are mailed and between 700 and 800 returned or about 16%. I commend those who exercise their right to vote and elect the delegates of their choice to represent them at National Convention. This is a big expense to the state and one that is required by law. So please take the time to VOTE.

Vote "No" to Benefit Reductions

Last month, we talked about the House Concurrent Budget Resolution 27 and the Senate Concurrent Budget Resolution 11.

The deadline for Congress to adopt a joint Budget Resolution was April 15th. This did not happen.

Now the House and the Senate leaders have appointed members to the Budget Conference Committee.

The task set before this committee is to draft a final fiscal year 2016 Budget that must pass both the House and the Senate.

Then this will be presented to the President.

Even though the Senate Budget was asking for \$170 billion deficit reduction compared to \$318 billion in the House Budget Proposal, federal employees are still the primary target.

We encourage everyone to contact their Representatives and Senators to vote "NO" to all these benefit reductions and service cuts.

One thing, not necessarily legislative, but after the "cyber intrusion" last year the NRLCA filed a complaint with the National Labor Relations Board (NLRB) charging the Postal Service with unfair labor practices. The Postal Service knew of the incident many months before informing employees or any of the Unions of the hacking. The trial is set for May 20, 2015.

All of the District meetings will be over by the time you get this Bulletin. I hope you were able to attend your meeting and converse with other rural carriers.

In closing, your President, Vice President, and myself are preparing to attend the Legislative Seminar in Washington DC; my hope is that we can give you positive feedback when we return.
