# Vote - Vote - Vote

In This newsletter issue, there are a number of documents that will be of assistance as you plan your visit to the polls in this critical fall election. Above is the schedule for Early Voting. This is important to have because we expect as many as 60%+ of the votes in Moore County will be cast before election day, Tuesday November 6. Later in this newsletter, there is a listing of the polling locations if you plan to vote on election day.

In addition, there are 2 informational election inserts (attachments on the email version of the newsletter):

1) A one page (front and back) sample ballot that was prepared by our Moore County GOP. This sample ballot shows all races and has the MC GOP recommended candidate filled in. Please be sure to review both sides and take a copy when you go vote. There are additional copies of this at the Moore County GOP Headquarters in Olmstead Village and there will be copies available at our October luncheon meeting.

2) A one page (front and back) document that explains the Moore County ½ cent sales tax. This tax will support educational needs and local officials have assured voters that proceeds will only be used for that purpose.

especially since Justice Bob Edmunds lost his election in 2016. Just as she did when she was an Appellate Court judge, Jackson is a voice of reason on the Supreme Court.



She is up for election in November and it is vital that she is re-elected for those who believe that government should be restrained with a good system of checks and balances. Jackson believes deeply that the courts should apply laws as written and not try to legislate from the bench.



Congressman Richard Hudson will also be in attendance. He is our current Congressman and is running for re-election in November. Congressman Hudson has be recognized as a top

Nothing is more energizing than joining Moore County Republicans (and others from surrounding counties) on a road trip. On Sept. 26, Republican stalwarts assembled on the West Lawn of the U.S. Capitol -- 2,000-plus -- to support FreedomWorks and Ohio Rep. Jim Jordan, the presumptive Speaker of the House should Republicans retain control of the House. Our Moore team traveled on a "red eye" by bus overnight, 30 hearty souls in all, including Hall of Famers such as Dee Park, Carol Wheeldon, ringleader Miriam Chu, Russ Vansant and Hal Mendelson.

On a partly cloudy, warm day, we heard from only A-list speakers. Radio talk show host Andrew Wilcow handled the introductions. We greeted speakers including our very own Cleta Mitchell, Kentucky Sen. Rand Paul, Texas Rep. Louie Gohmert, Florida Rep. Matt Gaetz, NC Freedom Caucus chair and Rep. Mark Meadows, and Ohio's Jordan, among others.

Later, the Moore and Lee County delegations assembled in a private meeting room in the Capitol Visitors Center to interact with our NC-8 Congressman Richard Hudson, who discussed his frustration over the lukewarm Congressional response to is Reciprocity Conceal & Carry firearms bill, as well as a decision by House leadership (backed by POTUS Trump, Hudson said) to delay a request for more border wall construction funding until after the mid-terms.

Afterward, the NC delegation boarded its bus for the return trip and several hours of well deserved rest. We should salute these patriots who sacrificed sleep, comfort and food to participate in this important event. They are a rare breed of Americans.

Voting starts soon, so plan your visit to one of the early voting locations or vote on Tuesday, November 6.

(Editor's Note: Member, John Boesch is involved in veteran's affairs in several organizations. Following is an update of a couple of events that impact veterans all over the country.)



**Senate Must Pass Blue Water** 

Navy Bill: In September, a coalition of veterans service organizations sent a letter to the Senate Committee on Veterans' Affairs urging the Senate to pass H.R. 299, the *Blue Water Navy Vietnam Veterans Act of 2018*, which would provide long-overdue benefits to Blue Water Navy and Korean DMZ veterans. It would also expand benefits to the children of veterans who were exposed to Agent Orange in Thailand and commission more research on Gulf War Illness.

National POW/MIA Recognition Day: On September 21, ceremonies at the Pentagon honored our nation's former prisoners of war and more than 82,000 Americans who remain missing and unaccounted for going back to World War II, as well as their families. The nation sets aside the third Friday in September to recognize and remember former POWs and our MIAs.

Yet, every day is another opportunity to recover, identify, and return a fallen American home to a loving family who still waits. The effort is carried on by the 700 military and civilian men and women assigned to the Defense POW/MIA Accounting Agency (DPAA).

Trump Signs Bill to Fund Veterans Programs: On September 21, the President signed the first appropriations bill of the year. The \$147.5 billion package includes full year appropriations for VA to start implementation of the VFW-supported VA MISSION Act of 2018, streamline the process for appealing decisions on benefit claims, reduce the rate of suicide among veterans, and modernize its electronic health care record.

The Trump Administration reached an agreement with Canada and Mexico on the largest trade deal in history, governing \$1.2 trillion in trade.

The results of a newly released <u>Gallup poll</u> indicates that the Republican Party is at a seven-year high in favorability among American voters.

The Dow Jones Industrial Average closed Oct. 2 at a record high (26,773.94), its 14th record close of 2018.

Consumer confidence rose in September to its highest level in about 18 years. The index rose nearly FOUR points since the August poll.

Across America, African American and Hispanic unemployment is at record lows due to Trump-led tax cuts and sweeping de-regulation that stifled business growth during the Obama years. Jobs and opportunities are flowing into communities.

Employment in North Carolina reflects trends nationwide. In our state, August employment reached an all-time high of more than 4.8 million jobs.

#### From Your Editor, Paul Shaffer:



This issue of the newsletter puts a strong and needed emphasis on the upcoming fall election. By the time you read this, we will be near or in the elections cycle. Early voting, as noted in an earlier article, starts on Wednesday, October 17. With as many as 60% or more of the

votes expected to be by early voters, we could possibly see some of the races decided even before the day the polls are open, November 6. Of course we will not know the vote count until after polling day, but the point is that we must get out to vote, we cannot afford to lay back and expect other conservative Republicans to carry the day. Vote early, vote on polling day, November 6, but whatever you do, get out and vote! Also, do not forget to encourage your like-minded friends to get out and vote and share the enclosed voting information.

In the September issue of the newsletter, I began to share some information from a book I recently completed: "Miracle At Philadelphia – The Story of the Constitutional Convention, May to September 1787." As I noted last month, the purpose of the convention was billed to be an "updating" of the Articles of Confederation. However, as we know, the result was to create an entirely new document, the United State Constitution. This new document outlined a government unlike any other in the world; In fact like no other government that had ever existed up to that time.

In this issue. following I describe in outline form what I read as the major issues faced by the

delegates to that convention:

- Small State concerns and issues vs. large states
- Representation of people; i.e. by population, by possession (wealth, land owned, net worth or what?) or by some other measure
- The number of "representatives" by state
- Status of slaves; i.e. should it be allowed, for how long and how should slaves be counted, if at all.
- The "branches" of government, how many, how elected, for how long.
- The power and control of states vs. a central government; i.e. as we know it even today: Federal vs. State rights
- The formation of an Executive Branch; i.e. a President, several Presidents, a "King" or what else and, if so, how long would one (or more) serve, with some delegates wanting "one" for life.
- How to elect (choose) the head(s) of an Executive Branch; i.e. an offshoot of the issue of small vs. large states resulting in a popular vote or other method (resulted in Electoral College voting process).
- The sharing of power between state government and national government, particularly consideration of trade, transportation control (shipping) and taxing authority.
- And an overall concern about whether a national government of any kind was needed (desired).

As you look these over, do they sound familiar as they do to me? We continue to this day to debate the same issues, in particular the popular vote vs. the Electoral College for choosing a President. Reading this book I learned or was reminded how close we came to NOT having a Constitution. This matter is a good business practice and organizations handle such matters with an exit interview.

And Trump is still keeping promises, and getting


