April Meeting Program News by Tom Adams – VP Programs:

Our topic for April's meeting is "Trillion dollar deficits: How the federal budget symbolizes a broken political system."

Join us for a conversation with Gregg Sherrill Chairman of Tenneco about America's perilous fiscal and political situation. Trillion dollar deficits are set to return within the next year and our already record high national debt will skyrocket over the coming decade. The political environment surrounding our debt and federal budget have come to symbolize the brokenness of our political system. Sherrill is a founding member of the Fix US initiative with the Campaign to Fix the Debt.



Gregg Sherrill is chairman of Tenneco Inc., a global manufacturer of Powertrain and Chassis components and systems for the automotive and commercial vehicle markets. He was chairman and CEO of Tenneco from 2007 to 2017. Before joining Tenneco in January 2007, he was with Johnson Controls Inc., a leading automotive supplier. Before Johnson Controls, Mr. Sherrill had 22 years of experience with Ford Motor Company, having served in a broad range of engineering and manufacturing positions. In addition to the Tenneco board, he serves on the boards of directors of SnapOn Inc. and the Allstate Corporation. He also serves on the National Governing Council of the Wilderness Society and is past chairman of the National Association of Manufacturers.

The Community in Action topic is Continuing the Mission which provides service dogs and service dog support for veterans living with the challenge of Post Traumatic Stress (PTS). Suzy Lutz the groups President will discuss their provision of outreach services, support throughout the pairing process, and post-pairing support to the veteran and service dog.

These uniquely trained companions provide companionship, a feeling of security and safety, and aid in the reintegration of everyday life. Continuing the Mission provides Assistance Dogs at no cost to the Veteran. Suzy will have a surprise special guest with her. You don't want to miss either of these two exciting speakers.

Another step forward for the Moore County GOP is the launch of our Twitter account. If Donald Trump is leveraging Twitter, so should we. Encourage Twitters lovers among friends and family to follow @gop_moore to be kept informed about events that impact all of us nationally and locally.

Our Instagram account, maintained by Lora Lowery, has aggregated 158 followers in no time at all. We shared photos with these followers on Mar. 23 during the Moore County Republican convention.

Meanwhile, Facebook continues to be our most powerful tool in the social media sphere. We launched promotion of the June 17 annual Republican Men's Club golf outing -- the club's principal fundraiser -- with a Facebook post that appeared for seven days and was boosted for \$50. Over those seven days, we reached 4,033 people and generated 70 clicks on the link to more information and registration. We plan to post additional ads on Facebook promoting the golf event as we move closer to the final countdown.

We hear the phrase "social justice" tossed around, specifically by a radical left which believes the world at large, but especially the United States of America, is inherently unjust. And they're going to do something about it.

If not so very symptomatic of our declining culture, revelations that dozens of wealthy (capitalist) citizens, mainly from liberal hotbeds in California and New York, paid enormous sums to ensure open (back) doors into prestigious universities for their children would be hilarious. At last, "socialism justice"!

Wildly successful people, pillars of their communities and professions, paid six- and even seven-figure bribes to make sure their kids would experience the finest anti-capitalism, pro-socialism, anti-free speech indoctrinations money can buy. They cast them out of the free markets trappings of wealth and privilege, and into the petri dishes of left wing radicalism, on campuses escalating hatred toward America as never before. An Army of foot soldiers to back Generalissimo Alexandria Ocasio-Cortez.

The money flowed into willing hands at Georgetown University, and the universities of California at Los Angeles (UCLA), Southern California (USC) and Texas, plus Stanford, Wake Forest and Yale. These are schools already bloated by funding from donors who orchestrate capitalist ventures to perfection only to willfully underwrite generations of snowflakes who long to shred the U.S. Constitution, airbrush American history, shut down speech they do not agree with, and shut down companies in pursuit of climate change retribution.

The hands which handed over half-a-million dollars and more to falsely credential these future "leaders" as worthy enrollees soon will be cut off or, at least, separated from their finger nails, but they don't care (and apparently neither do their criminal parents). Mommy and Daddy might end up on the streets. So be it. Socialism justice delivers tough sentences.

“(In all) 33 parents named in federal indictments (March 12) allegedly funneled at least \$25 million through a fraudulent college-counseling service to get their children (into prestigious schools),” reported *The Wall Street Journal*.

That represents a staggering investment, and for what? Once inside the gates, one might presume the rich kids would be all-in on setting their own paths to success in between Kardashian-themed parties, and embracing the heritage and traditions of these fine universities.

Nothing could be further from the truth. They hate heritage. They want a lot of administrators and faculty members fired. And they want statues torn down and buildings renamed (to sanitize any and all recognition of white people who came before them). Overlooked, is that many of the coddled campus protestors are products of so-called white privilege. But they prefer a status as permanently outraged over privileged.

Look no further than [scandalized Wake Forest](#), where the head volleyball coach was placed on administrative leave after the feds linked him to receipt of a \$100,000 bribe. It was paid by the ringleader of the fraudulent counseling operation to help one of his client’s children become identified as a “recruit” sought by the Wake volleyball program. Whether the recruit ever has played volleyball is unclear.

What is exceedingly clear is that bucolic Wake Forest University is quaking as students swarm its grounds, shouting demand upon demand. They have embraced a recent trend of scouring old yearbooks to search for photos that disqualify people for jobs currently held due to activity in which they engaged decades earlier. Two members of the Wake admissions office, ironically, have been ravaged by students who discovered them in yearbook photos posing in front of a Confederate flag.

One such target was Dean of Admissions Martha Allman, who in February was forced to issue a heartfelt apology because she was photographed in front of a Confederate flag as a Wake Forest student in 1982.

A self-proclaimed Anti-Racism Coalition was not satisfied with Allman’s apology, calling on the school’s president to voice “vehement condemnation” of the dean. And [that’s not all the coalition is demanding](#). It will not rest until forcing removal of “all monuments, plaques, busts, portraits, buildings, and other things on campus dedicated to Confederates, white supremacists and eugenicists.” When the dust settles after the mass dismantling, the group

seeks renaming of Wingate Hall, Taylor Residence Hall and Poteat Residence Hall.

Washington Wingate, a Baptist minister, was president of Wake Forest College before and after the Civil War. His crime? Wake Forest’s campus was closed during the War but its buildings were used to store Confederate States bonds. Sorry, Pastor, you’re outta here.

Wake Forest’s web site notes the campus has a [racial and ethnic diversity](#) rate of 29.3% (as of Fall 2017), which represents a 49% increase in diversity since 2010. You might think this would be acknowledged as a positive trend. Think again.

The Anti-Racism Coalition warns the administration that “higher admission rates of black students does not at all compensate for the anti-black racism that is consistently experienced here. We do not need temporary solutions for a deeply rooted institutional problem.”

But their parents will pay \$70,000 a year to cover [tuition, plus room and board](#) — or pay a volleyball coach even more — to safely deliver them to these hallowed places where discontent is deeply rooted, where every human emotion bubbling up in opposition to widespread social injustice is deeply rooted, where everything is deeply rooted except rampant hypocrisy. Hypocrisy has no roots but remains buried under elite soil, never to be exposed. Until, thanks to the feds, it so readily is.

Disaffected Democrats? How Party Registration Could Indicate Liberal Backlash in North Carolina | Longleaf Politics

For years, unaffiliated voters have been the fastest-growing category in North Carolina. But in large numbers, these unaffiliated voters are coming from a surprising place: the Democratic Party.

Voters switching from Democrat to unaffiliated make up the largest block of party-switchers since the beginning of 2018, according to a Longleaf Politics analysis of data from the State Board of Elections.

A total of 35,472 former Democrats left the party to become unaffiliated voters in 2018. That compares with 25,238 voters who switched from Republican to unaffiliated, though that type of party switching is a more common media storyline in the Trump era.

The same trend is holding true in 2019 as well. As of March 1, 5,169 Democrats had switched to unaffiliated status, compared with 4,411 Republicans.

Could this be a leading indicator of a backlash against the national Democratic Party?

North Carolina's Democratic Party has long had an unusual history with its national brethren. In general, the state's Democratic voters have been much more conservative. Democrats retained control of the General Assembly for decades after voters began reliably going red in national contests.

The turning point came only when the more liberal faction of the Democratic Party concentrated in the state's urban areas gained more power. In the 2010 elections, Republicans grabbed control of both houses of the General Assembly.

The national Democratic Party has continued to lurch to the left and gained more attention as potential 2020 presidential candidates jockey for position.

This dynamic is already showing up in the 2019 campaigns.

Though 2018 was a wave election for Democrats, it's the Republicans running in special congressional elections who are trying to nationalize the race.

The first TV ad in the 3rd Congressional District race, supporting Michele Nix, [attacks](#) New York congresswoman Alexandria Ocasio-Cortez. In the 9th Congressional District special election, Republican Matthew Ridenhour has also sought to [tie his opponent to](#) the controversial liberal figure [and with](#) Vermont Democratic Socialist Bernie Sanders.

The only path to victory in North Carolina elections includes unaffiliated voters

General election candidates need to both rally their party's base and grab a hold of unaffiliated voters. This group has proven willing to support either party, and their preference is heavily based on their impressions of the national party.

This will only become more true as unaffiliated voters [become the largest voting bloc](#) in more areas. This year, unaffiliated voters also became the largest group in Wake County.

John Boesch on Veterans Issues:

Several bills were introduced in March to ensure that the U.S. Department of Veterans Affairs has the resources it needs to care for America's heroes.



The "Veterans Healthcare Improvement Act" would require the Government Accountability Office (GAO) to conduct an

independent audit of VA's medical care budget so that Congress can ensure there are enough resources for vets to get the care they've earned and deserve. The "Build a Better VA Act" would fix a bureaucratic budgeting rule that is an unnecessary roadblock to quickly expanding veterans' access to VA care in underserved communities across the nation.

Veterans Healthcare Improvement Act:
In 2006, '07, and '08, VA ran out of money. Congress passed a law in 2009 requiring GAO to provide an independent analysis of the Department's healthcare funding needs. That requirement expired in 2013. Since then, VA has again run low on funds. The Veterans Healthcare Improvement Act would bring back this neutral GAO assessment so that Congress can better ensure VA has the resources necessary to support the care America's vets have earned and deserve.

Build a Better VA Act:
Every major VA medical facility lease with yearly rental costs over \$1 million must be authorized by Congress. Recently, bureaucratic budget battles in Congress have prevented these routine authorizations from moving forward. The Build a Better VA Act would eliminate this roadblock. Major medical facility leases would be authorized by resolution vs. legislation. This standard GSA process is used for other agency leases executed by the GSA. By eliminating much bureaucracy, this bill will help ensure that vets can access the care they need, especially in underserved communities.

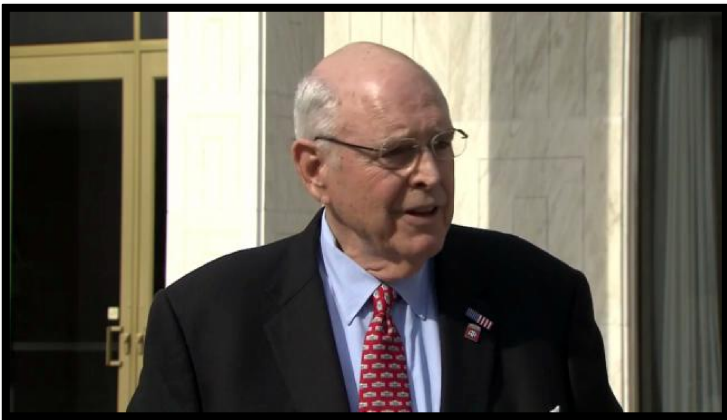

Indicted NC GOP chairman steps aside from party's daily operations

RALEIGH, N.C. — One day after he was **charged in an alleged scheme to bribe state Insurance Commissioner Mike Causey**, Robin Hayes on



Wednesday relinquished all of his day-to-day responsibilities as chairman of the North Carolina Republican Party. "In the best interest of the party, I make this announcement today and will let our respected officers lead on a temporary basis until our regularly planned party elections this June," Hayes said in a statement.

Hayes, a former congressman and GOP candidate for governor, announced Monday that he wouldn't seek re-election as GOP chairman, citing health reasons.

A federal grand jury in Charlotte indicted him, Durham businessman Greg Lindberg and two Lindberg business associates last month, but the **indictment remained sealed** until Tuesday, when all four men surrendered to the FBI and entered not guilty pleas in court.



Lindberg owns or is involved in hundreds of companies, including several regulated by the state Department of Insurance. According to the indictment, he wanted Causey to fire or reassign an unnamed deputy commissioner causing problems for some of the businesses, and he offered up to \$2 million in political donations to get it done.

Lindberg has given more than \$5 million to North Carolina political campaigns over the last few years, including more than \$1.49 million to the state Republican Party. The state party turned around and gave \$250,000 of that to Causey's campaign, and the indictment alleges this was an effort to get around state political giving rules, which allow unlimited donations to parties but cap individual campaign contributions at \$5,400.

Hayes is accused of agreeing to funnel the campaign money to Causey and of lying to FBI investigators when asked if any discussions had occurred involving Lindberg or his associates about directing some of the money to Causey.

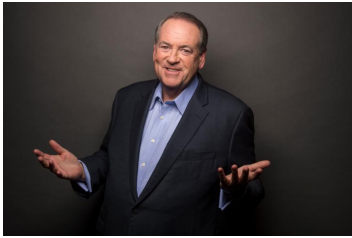
Causey cooperated with federal authorities in the investigation, including recording conversations he had with Hayes, Lindberg and the other two defendants, consultant John Gray and John Palermo, a vice president at Lindberg's Eli Global business and a former chairman of the Chatham County GOP.



Hayes appointed 11th District GOP Chairman Aubrey Woodard as acting chairman of the state GOP. Finance Chair K.D. Kennedy and state party Treasurer Jason Lemons also will assume expanded roles in the party's day-to-day finances.

"We look forward to a swift conclusion to this matter and clearing his name," Hayes' attorney, Kearns Davis, said in a statement. "Meanwhile, Mr. Hayes, in accordance with NCGOP rules, will allow others to lead while he heals from recent health setbacks."

In a shock announcement Tuesday morning, Cook County, Illinois, prosecutors dropped all 16 charges against "Empire" actor Jussie Smollett for allegedly

lying to Chicago police about faking a hate crime against himself and blaming it on Trump supporters. They released a statement reading:

"After reviewing all of the facts and circumstances of the case, including Mr. Smollett's volunteer service in the community and agreement to forfeit his (\$10,000) bond to the City of Chicago, we believe this outcome is a just disposition and appropriate resolution to this case." It was also claimed that Cook County State's Attorney Kim Foxx decided that was good enough, since the punishment would have just been community service. The case was then immediately sealed.

Smollett's lawyers said his record would be expunged and declared, "He was a victim who was vilified and made to appear as a perpetrator as a result of false and inappropriate remarks made to the public causing an inappropriate rush to judgment. Jussie and many others were hurt by these unfair and unwarranted actions. This entire situation is a reminder that there should never be an attempt to prove a case in the court of public opinion. That is wrong. It is a reminder that a victim, in this case Jussie, deserves dignity and respect. Dismissal of charges against the victim in this case was the only just result. Jussie is relieved to have this situation behind him and is very much looking forward to getting back to focusing on his family, friends and career."

But that's going over like a bottle of bleach in the punch bowl with many Chicago residents and leaders. Chicago Police Superintendent Eddie Johnson argued that an innocent person wouldn't forfeit \$10,000 bond and cut a secret plea deal behind closed doors. Johnson said, "Do I think justice was served? No. What do I think justice is? I think this city is still owed an apology. When I came on this job, I came on with my honor, my integrity, and my reputation. If someone accused me of doing anything that would circumvent that, I would want my day in court. Period. To clear my name. I have heard that they wanted their day in court with TV cameras, so America could know the truth, but no, they chose to hide behind secrecy and broker a deal to circumvent the judicial system."

This surprise rabbit-out-of-the-hat for Smollett might not be the end of the magic show, though. A lot of people are demanding answers and floating theories about which friends of Smollett (even the Obamas) might be powerful enough to have pulled strings for him. And there's still the matter of that alleged hoax threatening letter with a powdery substance on it that Chicago police say Smollett mailed to himself. That would be a federal charge, and so far, federal investigators aren't commenting.

In the meantime, I'd just add that when the 16 felony charges were handed down, I wrote this on March 9th:

"But before you get your hopes up that justice will actually be served, Chicago grand juries routinely return multiple charges that get knocked down to one guilty plea deal, so there's a good chance he won't even go to jail." Of course, I didn't think that meant all 16 charges would be dropped with no explanation and the public not allowed to see the details, but I guess that falls under the category of "The Chicago Way."

Oh, and in anticipation of the "What-about-ers" who will try to knock Republicans for criticizing Smollett while slamming the media for assuming Trump and Brett Kavanaugh were guilty, here's what I wrote the day of the first police press conference outlining the charges:

"(Disclaimer: I always respect due process rights so I

will stipulate up front that ‘Empire’ actor Jussie Smollett is still telling castmates that he ‘swears to God’ he didn’t fabricate the attack on him, and his attorneys insist that Chicago authorities trampled on his presumption of innocence by portraying him as definitely guilty in their press conference. Duly noted.)”

I’ll also point out the other big difference between the presumptions of guilt for Trump and Kavanaugh and for Smollett: in Smollett’s case, there was actual evidence of a crime that definitely existed. If you could find someone guilty on nothing but suspicion alone, then the Cook County prosecutors would now be going to jail.

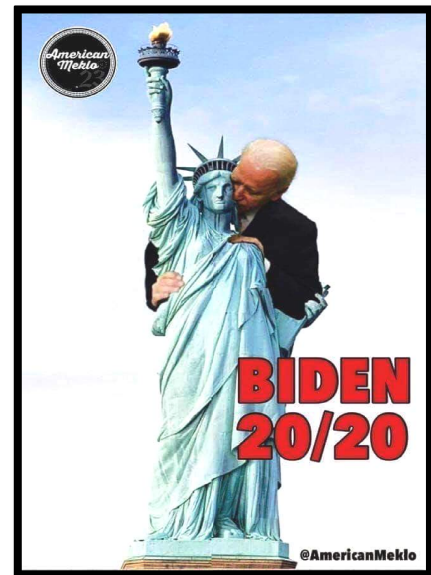
