Summary:

Under direct supervision, the Utility Worker is responsible for following a cleaning schedule and performing all cleaning duties for facilities, service vehicles, grounds, and equipment using provided products, tools, and procedures.

Essential Duties and Responsibilities:

This list is not intended to be a complete listing of all the job duties required of this position, but to provide information on the general scope of the position.

- Cleans and details interior of all vehicles including trash removal, sweeping, mopping, wipe down of high-touch surfaces and other surfaces, and interiors and exteriors of windows
- Follows all established cleaning and sanitation procedures to clean and detail all common areas; rooms, hallways, restrooms, lunch area, outdoor patio, nearby facilities, and other areas
- Uses computer or similar mobile device to complete work assignments, training and submit electronic forms for tracking of daily, weekly, and monthly cleaning activities on electronic database
- Maintains database by entering cleaning and sanitizing activity in a timely manner
- Responsible for maintaining equipment and storage rooms in a neat and clean condition; assists with keeping track of all products and supplies
- Perform a wide variety of cleaning tasks – including, but not limited to - dusting, sweeping, vacuuming, and wiping surfaces, including restrooms, lunch area, offices, outdoor patio, and other areas assigned
- Identifies and uses computer or similar mobile device to electronically document damages and communicates to appropriate personnel in the case of unreported damage
- Performs minor maintenance and repairs, changes lights, and cleans equipment
- Assists with moving furniture and equipment in preparation of company events, activities, and special projects
- Responsible for learning, reviewing, and following new safety, health, and cleaning procedures as needed
- Performs other related duties as assigned

- Ability to work nights, weekends, holidays, and variable schedule(s)
- Ability to read, write, speak, and understand English well enough to perform the essential job duties

- Ability to communicate effectively in both oral and written form
- Ability to understand and follow written and spoken instructions
- Ability to work independently as well as ability to establish and maintain cooperative work relationships
- Ability to perform work involving regular physical activity, observe safety requirements, and adhere to safe work practices and methods
- Ability to use mobile devices or similar to complete electronic forms
- Ability to move/lift to up to 50 pounds

Experience:

Special Requirements:

- Successful candidate must pass a pre-employment physical, drug, and background check

Working Conditions:

- Work may involve moderate exposure to unusual elements, such as extreme temperatures, dirt, dust, fumes, smoke, unpleasant odors, and/or loud noises
