- ➤ LBSA suspension of monthly sewage invoice to CMSA, this is a direct violation of the Amended Wastewater Transportation and Treatment Agreement of 2002.
- > LBSA Chairman and CMSA Chairman exchanged phone conversations about the suspension of payment for sewage invoicing.
- The 2010 Allocation payment to LBSA from Kotzan, CPA and Associates, per CMSA audited financial statements for the year ending December 31st, 2010.
- ➤ The discounted percentages on the 2010 Allocation derive from the original contract percentages under the joint facility factor.
- > LBSA concerns on Operations and Maintenance
