

TOWN COUNCIL MEETING

April 5, 2021

The Town Council met April 5, 2021 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Council Member Crumpton gave the invocation.

Mayor Hight asked for approval of the Council Minutes from March 15, 2021.

Council Member Littleton moved to approve the Council Minutes from March 15, 2021 as presented. Council Member Benson seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Council Member Benson moved to approve the Planning Comm. Minutes from March 9, 2021 as presented. Council Member Killingworth seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Old Business

Council Member Benson moved to approve the Park and Rec. minutes from March 7, 2021 but to exclude Field Rental rates from the Park and Rec. Minutes from March 7, 2021. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Council Member Killingworth moved to Amend Ordinance # 180 Article II. Section 7 to **All property licensed retail licensees of the alcohol beverage control board serving the public in the Town of on-premises and off-premises consumption are authorized to sell alcoholic beverage on Sunday between the hours of (10:00a.m. to 2:00a.m. on Monday.** Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson, Chapman. Nae: Crumpton.

New Business

Mayor reported to the Council that Dustin Cleckler at 18 Church St., his drainage issues has been fixed.

Council Member Littleton moved to approve Resolution #3-9-21 (Rezoning B.J. Ward property from Town Center Commercial to Residential Medium Density, at the corner of Medical Center Dr. and North Dakota Rd.) Council Member Killingsworth seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingsworth, Littleton, Benson Chapman and Crumpton.

Council Member Benson moved to approve Ordinance No. 04/05/2021 (Rezoning B.J. Ward property from Town Center Commercial to Residential Medium Density, at the corner of Medical Center Dr. and North Dakota Rd.) Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingsworth, Littleton, Benson Chapman and Crumpton.

Department Heads

Fire Chief Parker was not present.

Daniel Avery reported to the Council that Dustin Cleckler drainage issue was fixed. He stated that all material has been ordered for Franklin St. and Jones St.

Council Member Littleton asked about dumping at the sewer lagoon. Daniel stated he had to call the Company to come pump out the Hwy 31 sewer station because it was stopped up.

Chief Barnett asked the Council to hire Justin Tyler Mims as a part time police officer.

Council Member Benson moved to hire Justin Tyler Mims as a part time police officer. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingsworth, Littleton, Benson Chapman and Crumpton.

Mayor Hight reported to the Council he met with Alabama Power and the IDA last week about a Master Plan for the Town. Mayor Hight stated that they are willing to pay half of the Master Plan if the Town will pay the other half which is \$1500.00. Mayor Hight said this would help us to get grants.

Council Member Littleton moved to approve the \$1500.00 for the Master Plan for the Town. Council Member Killingsworth seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingsworth, Littleton, Benson Chapman and Crumpton.

Council Member Littleton stated that the Town still has several of the light post that are in Richard Wood park.

Council Member Littleton moved to approve the transfer of funds, and bills for April 5, 2021. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Crumpton, Chapman, Killingworth, and Benson.

Council Member Crumpton moved to go into an Executive Session to discuss litigation for 20 or 30 minutes. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Council Member Littleton moved to reopen to regular session. Council Member Benson seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Council Member Benson made a motion for pending legation and to accept mediation agreement. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

There being no further business to come before the council, Council Member Chapman moved to adjourn. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Benson, Crumpton, Chapman Killingworth and Littleton.
