PUBLIC HEARING – Call to Order

A Public Hearing concerning WAC 363-116-078 Training Program was convened at 10:00 a.m. by Chair Sheri Tonn in the Agate Conference Room, 2901 Third Avenue, Seattle, WA and online via Microsoft Teams.

WAC 363-116-078 Pilot Training Program. The purpose of the proposed rulemaking is to decouple the training stipend from training program job requirements, incorporate existing practices into the WAC language, restructure certain sections for clarity and flow, and conduct minor housekeeping in preparation for the upcoming 2024 Washington State Marine Pilot Exam and training of the successful applicants. There were no written public comments. Monique Webber, Pacific Yacht Management, inquired if the changes to the Pilot Training Program were requiring increased trainees per vessel, as she is seeing an increase in requests for trainees onboard. It was clarified that there were no increased requirements. Chair Tonn closed the Public Hearing at 10:05 a.m.

REGULAR MEETING – Call to Order

The Regular Meeting of the Board of Pilotage Commissioners was convened immediately following the Public Hearing by Chair Sheri Tonn in the Agate Conference Room, 2901 Third Avenue, Seattle, WA and online via Microsoft Teams. Chair Tonn commented on the in-person turnout, adding that it was the most people at an in-person Board meeting since February of 2020. Additionally, she welcomed the Board's Foreign Flag Shipping Representative Captain Richard Firth, Holland America Group. She also welcomed Sector Puget Sound Captain of the Port Captain Mark McDonnell who introduced himself and addressed the Board. The BPC looks forward to working with Captain McDonnell and a continued partnership with the USCG.

BPC Staff Report.

- ➤ Executive Director Jaimie Bever attended the Maritime Blue Equity Summit held in person on August 29. She reported that it was an excellent event and was well-attended, including by Puget Sound Pilots.
- ➤ Jaimie attended the Affiliated Tribes of Northwest Indians (ATNI) 2023 Conference held in Centralia on September 20. She presented on Tug Escort Rulemaking as a part of a 90-minute report from the Department of Ecology. She acknowledged Tyson Oreiro, Tribal Liaison for the Department of Ecology, and all of his efforts over the years to secure time at this annual event.
- ➤ Due to last minute legislative changes to the Board's 23/25 Biennial Budget, recruitment for the tug escort rulemaking project position has been suspended. Board staff will continue to work with DES, OFM, and legislative staff on a possible funding fix.
- ➤ WSF has begun the process of contract negotiations for the 2901 building lease which is up in August of 2025. With the state encouraging overall reduction in space, Jaimie is working with WSF on necessary accommodations for Board staff and public meetings.

BPC Chair Report.

- ➤ BPC Chair Sheri Tonn reported that Rear Admiral Ann Phillips of the United States Maritime Administration (MARAD) will be in Grays Harbor next week to celebrate the Terminal 4 expansion project. The Port of Grays Harbor will be hosting a luncheon, which Chair Tonn plans to attend.
- At Chair Tonn's invitation, Commissioner Firth introduced himself detailing his career and what led him to serve on the Board.

Activity Reports. Lindsay Wolpa representing The Northwest Seaport Alliance (NWSA), Mike Folkers and Gary Nelson representing the Port of Grays Harbor (PGH), Ivan Carlson representing Puget Sound Pilots (PSP), and Laird Hail along with Kira Moody representing the United States Coast Guard (USCG) offered current and projected statistical data as well as updates on current maritime issues and activities.

BPC Data Analyst Bettina Maki shared the Puget Sound Pilots Activity Report dashboard and was available for questions.

Meeting Minutes.

Motion: Hamilton/Anthony – approve the August 17, 2023, Meeting Minutes as drafted – Carried.

Presentation: Quiet Sound Program – Admiralty Inlet/North Puget Sound Voluntary Vessel Slowdown for Southern Resident Killer Whale Protection – Rachel Aronson, Quiet Sound Program Director. Rachel Aronson provided an overview of the 2023-2024 voluntary vessel slowdown parameters and shared results from the previous trial. She also answered questions from the Board and the public.

Committee Actions.

Trainee Evaluation Committee (TEC)

- ➤ TEC Chair Captain Bendixen reported that there are currently 14 pilots in their upgrading window. The Board reviewed 5 draft upgrade letters, for 4 pilots in Puget Sound and 1 in Grays Harbor.

 Motion: Bendixen/Anthony approve the pilot license upgrade program for Captains Grieser, Grobschmit, McGrath, Miller & Velarde as recommended by the TEC Carried.
- Executive Director Bever acknowledged Captain Bendixen's recent graduation to unlimited pilot.
- PSP President Recency Trip Requirements: The Board reviewed a draft letter, which reflected the policy of the BPC as well as reflects current vessel traffic trends. The TEC reviewed and recommended to the Board the letter as written.
 - <u>Motion</u>: Bendixen/Hamilton approve the PSP President Recency Trip Requirements for Captain Carlson as recommended by the TEC Carried.
- New trainee orientation for Captains Michelson, Wood, & Sabbath was held Tuesday, August 29 and went very well.
- The TEC met yesterday and reviewed all trainee progress. There are currently 9 trainees in PS and zero trainees in GH. In Puget Sound, there are 3 trainees in Evaluation, 3 in Training and the 3 new trainees are in Observation. All are progressing well.
- ➤ TEC Chair Bendixen reported that challenges continue at the REC and as of today there has been no follow up from the August meeting of the federal pilotage work group.

Pilot Exam Committee (PEC)

- > Training Program Manager Jolene Hamel highlighted the details and changes to the application materials for the Spring 2024 Marine Pilot Exam.
 - <u>Motion</u>: Bendixen/Hamilton– affirm the application materials for the 2024 Marine Pilot Exam as recommended by the PEC Carried.
- > Jolene also reiterated the important dates and discussed some of the many avenues that the BPC will utilize to get the word out regarding the Exam.
- ➤ BPC Chair Tonn shared her appreciation for the pilots who have helped with the exam process so far. The BPC will write a letter to the pilots of both Puget Sound and Grays Harbor thanking them for their efforts.

Diversity, Equity & Inclusion Committee (DEIC)

- ➤ Executive Director Jaimie Bever shared information about the upcoming Women Offshore Conference taking place October 26 & 27 at Texas A&M. Both she and Jolene Hamel will be attending from the BPC.
 - Motion: Bendixen/Anthony approve the BPC to sponsor the 2023 Women Offshore Conference at the \$1.000 level Carried.
- ➤ Jaimie also shared that she attended the first in-person meeting of the WSF DAG (Diversity Advisory Group). Assistant Secretary Patty Rubstello attended to recognize the group's efforts. Jaimie has also been invited to sit on the Scholarship panel interviews for the MITAGS MAP Scholarship program.

BPC Chair Tonn suggested it was time to revisit the RCW/WAC governing pilot physicals given that the current state physical requirements are stricter than the USCG physical requirements for Federal licensure.

> The PSC has not met since the last Board meeting. The next meeting will be October 12.

Vessel Exemption Committee (VEC)

➤ VEC Chair Mike Anthony walked the Board through the proposed recommended fee changes and what else the committee wishes to tackle through future legislation. A CR 102 will be provided to the Board at the October meeting.

Oil Transportation Safety Committee (OTSC)

- ➤ The committee met last on September 14 for a pre-workshop #3 meeting. OTSC Chair Jaimie Bever sent out an email with a status update on the risk model report as well as dates for the upcoming workshops.
- Tug Escort Rulemaking Updates: The fourth workshop will take place in December and will be focused on the risk model analysis results. A fifth workshop will take place in early 2024 as well as workshops all next year.
- For review, the Board received comments received so far from tribes and stakeholders regarding Tug Escort Rulemaking development.

Public Comment. Chair Tonn asked for public comment, but none was offered.

Confirmation of Next Regular Meeting Dates. Chair Tonn reminded everyone of the upcoming meetings in October and November. All meetings continue to be hybrid, and all are invited and encouraged to come in person. She also reported that KPI Workshop #3 will be held at the November 16th meeting, to best suit Board schedules.

Adjourn. Meeting was adjourned by Chair Tonn at 1:00pm.
