(Flooding etc.) (Mudslides)

ORDINANCE NO./..... **SERIES 1975**

WHEREAS, certain areas of the Town of Marble are subject to periodic flooding (and/or mudslides) from (STREAMS, RIVERS, ETC.); causing serious damages to properties within these areas; and

WHEREAS, relief is available in the form of Federally subsidized flood insurance as authorized by the National Fllod Insurance Act of 1968; and

WHEREAS, it is the intent of this Board of Trustees to require the recognition and evaluation of flood and/or mudslides hazards in all official actions relating to land use in the flood plain, and/or mudslide areas having special flood, and/or mudslide hazards,

WHEREAS, this body has the legal authority to adopt land use and control measures to reduce future flood losses.

RESOLVED, that this Board of NOW THEREFORE BE IT Trustees hereby:

Assures the Federal Insurance Administration that it will enact as necessary, and maintain in force for those areas having flood or mudslide hazards, adequate land use and control measures with effective enforcement provisions consistent with the Criteria set forth in Section 1910 of the National Flood Insurance Program Regulations; and

2. Vests the Zoning Enforcement Office with the

responsibility, authority, and means to:

(a) Delineate or assist the Administrator, at his request, in delineating the limits of the areas having special flood, and/or mudslide hazards on available maps of sufficient scale to identify the location of building sites.

(b) Provide such information as the Administrator may request concerning present uses and occupancy of

the floodplain, and/or mudslide area.
(c) Cooperate with Federal, State, and Local agencies and private firms, which undertake to study, survey, map, and identify flood plain or mudslide areas, and cooperate with neighboring communities with respect to management of adjoining flood plain, and/or mudslide areas in order to prevent aggravation of existing hazards.

Submit on the anniversary date of the community's (d) initial eligibility an annual report to the Administrator on the progress made during the past year with the community in the development and implementation of flood

plain, and/ormudslide area management measures.

Appaints the Zoning Emforcement Officer to maintain for public inspection and to furnish upon request a record of elevations (in relation to mean sea level) of the lowest floor (including basement) of all new or substantially improved structures located in the special flood hazard areas, if the lowest floor is below *. grade on one or more sides, the elevation of the floor immediately above must also be recorded.

4. Agrees to take such other official action as may be reasonably necessary to carry out the objectives of

the program.
