

Privacy Policy

This Privacy Policy tells you how we protect and use information that we gather from you when you access this website. By using this website, you consent to the terms described in the most recent version of this Privacy Policy. You should also read our [Terms](#) to understand the general rules about your use of this website, and our Terms of Sale when you purchase any products from us, including sales through this website. "We," "our," or "us" means Signature Soy, Inc. and its affiliates. "You," "User(s)," and similar words means the individual accessing this site.

Our Privacy Policy identifies how we treat your private and public information.

What is public information and how is it collected and used? Public information is information that is publicly known, or information that cannot identify you as an individual person. Because this information cannot identify you or be tied to you personally in any way, there are no restrictions on the ways that we can use or share such public information.

What is private information and how is it collected? Private information is information that identifies you as an individual, such as your name, mailing address, e-mail address, telephone number, and fax number, which you give us for limited purposes. We may collect private information from you in a variety of ways when you fill out an online form or survey, or when you conduct an online transaction with us.

Are cookies or other technologies used to collect private information? No, we do not use cookies or other technologies to collect private information. However, if you visit the website to read or download information, we may collect certain public information about you from your computer. This information is collected from your computer's web browser.

How does Signature Soy use private information? We may keep and use private information we collect from or about you to provide you with access to the website or other products or services, to respond to your requests, to bill you for products you purchased, to provide ongoing service and support, to contact you with information that might be of interest to you, including information about products and services of ours and of others, or ask for your opinion about our services or the products of others, for record keeping and analytical purposes and to research, develop and improve programs, products, services and website Content. Private information collected online may be combined with information you provide to us through other sources. We may also remove your private identifiers (your name, e-mail address, address, etc). In this case, you would no longer be identified as a single unique individual. Once we have de-identified information, it is no longer private information and we may treat it like other public information. Finally, we may use your private information to protect our rights or property, or to protect someone's health, safety or welfare, and to comply with a law or regulation, court order or other legal process.

Does Signature Soy share private information with others? We will not share your private information collected from the website with an unrelated third party without your permission, except as otherwise provided in this Privacy Policy. In the ordinary course of business, we may share some private information with companies that we hire to perform services or functions on our behalf. In all cases in which we share your private information with a third party for the purpose of providing a service to us, we will prohibit them from keeping, disclosing or using your information except for the purpose of providing the services we asked them to provide. We will not sell exchange or publish your private information, except in conjunction with a corporate sale, merger, dissolution, or acquisition.

We may be legally compelled to release your private information in response to a court order, subpoena, search warrant, law or regulation. We may cooperate with law enforcement authorities in investigating and prosecuting website visitors who violate our rules or engage in behavior which is harmful to other visitors (or illegal). We also may disclose your private information to third parties if we feel that the disclosure is necessary to protect our rights or property, protect someone's health, safety or welfare, or to comply with a law or regulation, court order or other legal process.

How is private information used for communications? We may contact you periodically by e-mail, mail or telephone to provide information regarding programs, products, services and website Content that may be of interest to you. In addition, some of the features on the website allow you to communicate with us using an online form. If your communication requests a response from us, we may send you a response via e-mail. The e-mail response or confirmation may include your private information. We cannot guarantee that our e-mails to you will be secure from unauthorized interception.

How is private information secured? We have implemented generally accepted standards of technology and operational security in order to protect privately-identifiable information from loss, misuse, alteration, or destruction. Only authorized personnel and third party vendors have access to your private information, and these employees and vendors are required to treat this information as confidential. Despite these precautions, we cannot guarantee that unauthorized persons will not obtain access to your private information.

How can a user access, change, and/or delete private information? You may access, correct, update, and/or delete any private personally-identifiable information that you submit to the website. You may also unsubscribe from mailing lists or any registrations on the website.
