The YYACC/CYBHWG did write a statement of support that was submitted as part of their recommendations to legislature to show support for a funding request in the amount of approximately 8 million dollars to help resolve some of the NEMT challenges being experienced by youth and families as reported by regional FYSPRTs across Washington.
