2. Indicate, by title and amount, any financial assistance that you will be receiving.
3. Have mailed directly to the North Texas Chapter (see awards chairman address on cover page), to be received no later than December 31st deadline, with the following:
  - a. Forms for recommendation, completion by teachers or faculty members is preferred.
  - b. An up-to-date copy of your high school or college transcript of academic record.
  - c. ACT or SAT scores.
4. Return to the North Texas Chapter each completed application with any other required submittal or requested information. Include a letter stating your intent or desire to have the NTC Scholarship and why. This letter should not exceed two typed pages.

## CRITERIA OF QUALIFICATION OF APPLICANT

1. The Awards Committee may establish reasonable and operable procedures and qualifications for determining the selection of the student or students considered as recipients of grants from the Educational Fund, provided it is not in conflict with criteria or guidelines herein stated,
2. The student applicant shall be a son, daughter or relative of living, retired or deceased building department personnel of a city; further, that such city personnel shall have been an active member of NTC for three years prior to application. The student applicant shall agree that the use of the grant funds shall be predicated on his or her enrollment or continuance of education in a recognized and/or accredited school such as college, university, trade school, Business College, or as may be acceptable to the Awards Committee.
3. The applicant shall show the need for financial assistants.
4. The applicant should possess qualities of good character and integrity.
5. A record of evidence of satisfactory scholastic or school grades, ability, ambition, and desire for continuance of education shall be submitted. The grant of funds may be utilized by a student for continuation to succeeding year or years upon satisfactory academic process, subject to review by the Committee. The maximum number of years that funds may be granted a student is four years. All students desiring continuation of funding must make an application each year using this form except for Instruction to the Applicant.

I solemnly affirm to the correctness of the information supplied in this Application, and that I have thoroughly read and understand the "Instruction to Applicant" and the "Criteria of Qualification" as transmitted herewith. If grant is provided, I agree and promise to use it for no other purpose than as set forth in the "Criteria of Qualification."
