# TOWN OF PREECEVILLE **BYLAW NO. 2-2019**

## A BYLAW TO AUTHORIZE PAYMENT OF WAGES AND ACCOUNTS

The Council of the Town of Preeceville, in the Province of Saskatchewan, enacts as follows:

- 1. The Administrator, jointly with the Mayor or Deputy Mayor are hereby authorized to pay the wages of municipal employees, as well as all employee deductions and employer contributions required by law with respect to those wages on a biweekly/monthly basis.
- 2. The Administrator, jointly with the Mayor or Deputy Mayor are hereby authorized to pay the following utility accounts against the Municipality: SaskPower, SaskEnergy, Sasktel, Sasktel Mobility, and Access Communications.
- 3. The Administrator, jointly with the Mayor or Deputy Mayor are hereby authorized to pay the following accounts against the Municipality: Minister of Finance -Good Spirit School Division, Reciever General, Municipal Employee Pension Plan, SUMA Group Benefits, Sanitation Contract, vehicle licencing and registration fees, pre-authorized per diems, pre-authorized registration fees as well as any payment of grants/donations monies received on behalf of Community or Town Boards.
- 4. The Administrator shall, at the Council meeting next following the payment of accounts as per sections 1, 2, and 3 advise Council of the following:

  a) the date and number of the cheque

- b) the amount of the chequec) the payee of the cheque

and if applicable:

- d) the name of the recipient utility
- e) the amount of the electronic transfer
- 5. Bylaw No. 3-1993 is hereby repealed.
- 6. This bylaw shall come into force and effect upon final passing.
