Rev. Preston has served in the Churches of God in Christ under great leaders such as Bishop Robert J. Darret, Bishop R. E. Woodard, Sr., Bishop T. D. Iglehart and Bishop Nathaniel H. Henderson. In 1984 Rev. T. Leon Preston II was licensed to preach in the Churches of God In Christ by Bishop Robert J. Darret. December 1985, Rev. Preston became Pastoral Assistant to Rev. Dr. James C. Franklin of the Greater St. James Missionary Baptist Church. Rev. Preston served faithfully as Assistant Pastor until he was called to organize a church, in 1989.

In 1989, at the Texas Southeast First Ecclesiastical Jurisdictional Convocation Rev. Preston was ordained an Elder in the Churches of God in Christ, Supt. Pinkston Bell Sr. was the Chairman of the Ordination Board, Bishop R. E. Woodard Sr. was Jurisdictional Prelate. In 1990-1991, Rev. Preston served as District YPWW President of the Southwest District of Texas Southcentral Jurisdiction under Elder. S. O. Brown, District Superintendent, Bishop N. H. Henderson, Jurisdictional Prelate.
