### **CONSTITUTION & BYLAWS**

### December 2019

Hello members of the American Legion Auxiliary Department of AZ.

Per my September bulletin, Every Unit of the American Legion Auxiliary must immediately rewrite the eligibility within each Units Constitution. In my September new verbiage, in item 3 I left out one word **Sisters** corrected verbiage is below. Please excuse my error.

New Verbiage: can also be found on the national website: https://www.alaforveterans.org/Members/Consitution---Bylaws/

When the Legion changes the eligibility, our Auxiliary eligibility automatically changes. No vote for approval at your meetings is needed.

#### New Verbiage:

The American Legion recognizes and auxiliary organization, known as The American Legion Auxiliary....

Membership in The American Legion Auxiliary shall be limited to the:

- (1) grandmothers, mothers, sisters, spouses and direct and adopted female descendants of members of The American Legion; and
- (2) grandmothers, mothers, sisters, spouses and direct and adopted female descendants of all men and women who served in either of the following periods: April 6, 1917, to November 11, 1918, and any time after December 7, 1941, who, being a citizen of the United States at the time of their entry therein served on active duty in the Armed Forces of any of the governments associated with the United States during either eligibility periods and died in the line of duty or after honorable discharge;
- (3) grandmothers, mothers, sisters spouses, and direct and adopted female descendants of all men and women who were in the Armed Forces of the United States during either of the following periods: April 6, 1917, to November 11, 1918; and any time after December 7, 1941 who served on active duty in the Armed Forces of the United States during eligibility periods and died in the line of duty or after honorable discharge; and
- (4) to those women who of their own right are eligible for membership in the American Legion
- The latest version of our Constitution & Bylaws document includes an update to the <u>ALA's Preamble</u> in which "<u>the great Wars</u>" becomes "all wars". Please trash all old copies of Preamble and replace with new copies for your members.
- So you think Constitution & By Laws are boring and dull? It can be very interesting.
- Consider a Unit without rules or guidelines. There would be chaos at all meetings. Everyone would be talking at once, no
  one would understand what anyone was stating and no agenda. Could you really see your Unit being productive in that
  type of atmosphere? The Constitution & By laws allow governing of your Unit and states in black and white what the
  formal policies and procedures are.
- Your Unit's Constitution & By Laws should be reviewed and revised as needed, each year and changes need to be sent to the Department Constitution & By Laws chairman.
- Each Unit operates under their own C&B altered to meet their local conditions. However, a Units C&B cannot violate any
  provisions of the Department or National organizations rules. I.E. payment for mileage cannot exceed what the
  Department pays.
- Post/Units should have chairman to keep their members abreast of any changes to Department or National Constitutions as well as Policies and Procedures.
- Please send a revised copy to this chairman. Since September, I have received info from only 2 units. I see a problem here.

### "Serving Those Behind the Badge"

**Special 100th Anniversary History Program Facts:** In 1934, the following change to the American Legion Auxiliary Constitution was adopted: To strike out Section 2, Article III, which is the article on Eligibility and substitute the following:

"Section 2. There shall be two classes of membership, Senior and Junior. (a) Senior membership shall be the functioning (or active) group composed of members over the age of eighteen years. (b) Junior membership shall consist of that group under the age of eighteen years, whose activities shall be supervised by the senior membership. Upon reaching the age of eighteen years, Junior members shall automatically be admitted into active membership with full privileges. (c) Dues of both classes shall be paid annually."

In the 1936-1937 year, under National President Scar W. Hahn, the Junior Program was launched. Junior membership grew from 29,000 to 40,000 during that following year due to the great work the Juniors were doing.

Taking the time to share a favorite story about the positive impact you or someone you know has had on our mission is worth doing! It helps us tell the world who we are, what we do, and why we matter. Just two simple steps to add our part to the national success story:

### **Junior Activities Reporting:**

Mid-Year Reports Mid-Year reports reflect the program work of units in the department and are intended as an opportunity for mid-year correction. Each department Junior Activities chairman is required to submit a narrative report by December 15, 2019 to the department Junior Activities chairman.

Now that we have all returned from Fall Conference, I have a few things.

10/24/19 - A bill requiring the POW/MIA flag to be flown with the American flag is on the verge of becoming law.

The bipartisan bill -- the National POW/MIA Act, introduced in the Senate by Sen. Elizabeth Warren, D-Massachusetts, requires the POW/MIA flag to be flown with the American flag at certain memorials and federal buildings, including the White House

and the U.S. Capitol, to honor unaccounted for servicemen and servicewomen from across more than 50 years of wars and

conflicts. "As the sister of three veterans, I understand the importance of honoring the sacrifices of those who have fought

courageously for our country," said Warren, who is a presidential candidate for the 2020 election. The bill passed through both

chambers of Congress, and now President Donald Trump must sign it into law.

11/08/19 - Trump signed POW/MIA Flag Bill into law.

11/14/19 – Public hearings started on the impeachment of President Trump.

Mid-Year reports are due to me by either email or snail mail no later than December 15, 2019. I need your input for my report to National.

In conclusion, please write letters to your Congressmen and women about healthcare and Medicare benefits and to ensure long term adequacy and stability of social security.



### UAV UNOFFICIAL MINUTES 2 NOVMBER 2019

The meeting was called to order at 10:04 a.m. by Chairman Dylan Dalzotto, the opening ceremony was conducted and special guests were introduced.

David Lucier gave an update on the attempts to establish a Fisher House in Phoenix. A Fisher House is a comfort house for the family of hospitalized Veterans. Applications are only accepted during a designated period. The next date to make application is in September 2020. This is a multi-million dollar project and is a joint venture between the UAV and AVHOFS. First we need to acquire the land. To find out more about the process to apply for a Fisher House you can google Fisher House Foundation. Phoenix is the last major city in America that does not have a Fisher House.

Rick Clark & Pennie Jensen, Loan Officers, from US Bank briefed the members of their program for veterans desiring to purchase a house. When you apply, they lock in the interest rate and it will only change if the interest rate goes down upon signing. Lee Lange from the Arizona for Fair Lending Act, briefed on the procedures that the Title Loan Companies charge in interest. Currently they can charge up to 200% which results in 1 in 3 goes into default, and 1 in 5 lose their car. They are trying to get an initiative on the ballot in 2020 to stop these companies from doing business in Arizona. For more information you can contact Lee at Iflange48@gmail.com

Roll call was taken and a quorum was established. A motion was made and second to approve the minutes from the previous meeting and approved.

There was no financial report given this month.

A representative from Congressional Representative Stanton's office gave a report on legislation that Representative Stanton is working on. (see attached flyer)

Dr. Alysia Smith, Interim Medical Director for the VA Medical Facilities updated the membership on several issues the VA is currently dealing with. She reported that the newly established Veterans Resource Center has serviced over 9,000 veterans and has been able to resolve most of their problems. The VA is hosting a "VetsGiving" on Saturday, November 23, from 10:00 a.m. to 1:00 p.m. (See attached flyer)

Trey Austin and Rachel Charles updated everyone on the activities ongoing at the VA National Cemetery here in Phoenix. The current Administration Building will be undergoing repairs so they will be moving into a temporary trailer. The maintenance building will also be undergoing major repairs. The entire project is expected to last about three years and will add about 25 more acres to the facilities. San Carlos has a National Cemetery and was officially opened a few week

s ago when the interned their first veteran's remains. A second internment is scheduled to take place in about two weeks. They also informed the membership that there are two GS-06 positions open. The closing is November 7<sup>th</sup>.

John Scott from ADVS briefed on the newly established pre-9-11 MFRF. They have finally put together the board to oversea the fund and had their first meeting on October 31<sup>st</sup>. To qualify for money from this fund, you must have deployed from the State of Arizona. Currently there is \$11,000 in the fund. They recently had a Gold Star Member dedication ceremony.

They interned the remains of 37 unclaimed veterans at the Marana Cemetery.

There is no cap on the amount of money they can accept into the MFRF, but anything over \$1 million there is no tax credit. When they reach the million dollar amount the contact the donator to see if they want to put the money somewhere else.

They just completed a VBC Conference. They have the conferences twice a year.

The VBC bring in \$18 million a month to the Arizona economy.

The State Legislative session will be opening soon. If you wish to speak on any of the subject legislations you need to be registered. If you are not registered and need help, please contact Jennifer Harris at the Department of Veteran Services.

The construction is on track for the Veterans Home in Yuma.

Request for Veterans Donation Fund Grants is on the Web.

Reggie Yates gave a report of the AVHOF Luncheon. This was the 19<sup>th</sup> Anniversary and there were 537 in attendance. They are looking for some suggestions for next year's 20<sup>th</sup> Anniversary.

Reggie Yates, chairman of the nomination committee presented the slate of officers for the upcoming year, Judith Hatch motioned that the slate be accepted and that the chair cast one vote for the selections, motion was second and approved.

The newly elected officers were sworn into office.

There will be no UAV meeting in December, since it falls on Pearl Harbor Day. The next meeting of the UAV will be on Saturday, January 4, 2020 at the VA Medical Center.

There being no further business to come before the membership, the closing ceremony was conducted and the meeting was adjourned.

"It is not only Congress's responsibility, but our duty as Americans, to honor our veterans for the sacrifices they made for our country" **said Rep. Greg Stanton.** "I am committed to ensuring the brave men and women who served in the Armed Forces have the equipment and support they need during their service, as well as access to the benefits, health care, and affordable housing they deserve once they leave the service."

#### Congressman Stanton's Actions:

- BECAME LAW: Cosponsor, H.R. 299, Blue Water Navy Vietnam Veterans Act. This law will restore Department of Veterans Affairs benefits to over 90,000 Blue Water Navy veterans who had their disability eligibility taken away in 2002 after regulatory changes. This law will also help other veterans and their families who suffer from conditions related to toxic exposures during the Vietnam War.
- PASSED HOUSE: Cosponsor, H.R. 886: Veteran Treatment Court Coordination Act. This bill
  directs the Department of Justice to establish a Veterans Treatment Court Program to provide grants and
  technical assistance for state, local, and tribal governments to develop and maintain Veterans Treatment
  Courts, which allow veterans charged with a non-violent crime attributed to physical or mental condition
  tied to their military service to receive court-supervised, comprehensive treatment.
- PASSED HOUSE: Cosponsor, H.R. 95: The Homeless Veteran Families Act. This bill authorizes the Department of Veterans Affairs to pay partial per diem for children accompanying a homeless veteran as part of the Homeless Providers Grant Program.
- Cosponsor, H.R. 2435: Accelerating Veterans Recovery Outdoors Act. This bill will create a task force of federal agencies to identify barriers to utilizing U.S. public lands in order to treat veterans and provide recreation programs. Outdoor recreation is proven to help veterans suffering from PTSD.
- Cosponsor, H.R. 955, Women Veterans and Families Health Services Act. This bill improves the
  reproductive assistance provided by the Department of Defense and the Department of Veterans Affairs
  to severely wounded, ill, or injured members of the Armed Forces, veterans, and their spouses.
- Cosponsor, H.R. 4137, Jennifer Kepner HOPE Act. This bill provides for the eligibility of veterans
  exposed to burn pits for hospital care, medical services, and nursing home care furnished by the
  Department of Veterans Affairs.
- Cosponsor, H.R. 3598, The FREED Vets Act. This bill requires that the Department of Education automatically discharge the student debt of veterans with total and permanent disability designations.
- Cosponsor, H.R. 2056, WWII U.S. Cadet Nurse Corps Service Recognition Act. This bill will
  recognize and honor the service of nurses who served as WWII cadet nurses.
  - o Included in the House passed National Defense Authorization Act.
- Cosigner, funding for veterans' programs. Signed two letters requesting increased funding for veteran suicide prevention programs and funding for the Veteran Supportive Housing (HUD-VASH) Program, which provides housing vouchers for homeless veterans.
