## TO BE COMPLETED BY LICENSED PLUMBER OF YOUR CHOOSING

I, a plumber licensed by the state of Illinois, certify that I have received a copy of CHAPTER 8 – DRAINAGE of the MUNICIPAL CODE OF SHERIDAN and agree to abide by such including without limit the following provisions:

- -Procure public liability insurance in an amount not less than \$100,000 for injuries, including accidental death, to any one person and subject to the same limit for each person in an amount not less than \$300,000 on account of one accident, and property damage insurance in an amount not less than \$100,000.00. The Village of Sheridan shall be named as an additional insured party (not merely a certificate holder). Proof of insurance shall be filed with Village prior to the commencement of any work.
- -Procure a performance bond with corporate surety thereon in the sum of the greater of \$1,000 or 100% of the estimated cost of the work to be done. Such performance bond shall be approved by the Village Attorney, conditioned upon the applicant indemnifying, saving harmless and agreeing to pay for the costs of defense incurred by the Village, for all damage to underground utilities, or to the water lines from any failure to restore any road, ditch, pavement or portion thereof damaged during the construction of the sewer connection, or the sewer extension to the condition existing at the commencement of construction.
- -File with the Village Plumber anticipated repair plans, specifications, or other information reasonably required by the Village Plumber or Village Engineer.
- -Allow inspections and pay inspection fees as required by the Village Plumbing Inspector.
- -Work shall comply with the building codes as established by the "CABO ONE AND TWO FAMILY DWELLING CODE" and the procedures set forth in that publication entitled *Standard Specifications for Water and Sewer Main Construction in Illinois*, published by the Standard Specifications Committee of the Illinois Society of Professional Engineers, and other similar organizations, third edition.
- -All excavations required for sewer work shall be open trench work unless otherwise approved by the Village. No backfill shall be placed until the work has been inspected by the Plumbing Inspector.
- -All excavations shall be adequately guarded with barricades and lights so as to protect the public from hazard. Streets, sidewalks, parkways and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the Village.
