**TITLE: APPROVAL OF DATA SHARING AGREEMENT WITH
NORTHWEST NEVADA SAGEBRUSH WORKING GROUP
(NWNVSWG)**

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

WHEREAS, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, and plants within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and

WHEREAS, the NRD wishes to enter into a data sharing agreement (DSA) with the Northwest Nevada Sagebrush Working Group; and

WHEREAS, the vision of the working group is to invest and engage in strong partnerships across all lands in the planning area and collaboratively identify priority areas of sagebrush conservation to develop and coordinate strategic management actions; and

WHEREAS, the goal of the working group is the long term health and resilience of the sagebrush community in northwest Nevada, and the threats are invasive annual grasses, wildfire, and conifer encroachment; and

WHEREAS, the spatial database is private (invite only) and all members will be subject to DSA; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby approves to enter into a DSA with NWNVSWG for the above stated purpose; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
