**FROM THE WEST:** L.I.E. To exit 66. Turn right on Sills Rd, Rt. 101. Get on Sunrise Highway WEST. Get off at exit 54. Left on Sunrise Highway Service Rd. Right on Hospital Rd. Left on Fish Thicket Rd. Fish Thicket turns into Barton Ave. 361 is on the right.

**FROM THE EAST:** Same as above only turning left on Sills Rd. OR Take Sunrise Highway West to Exit 54 and follow above directions from Exit 54.
