### ORDINANCE NO. 2025- <u>7</u>

## AN ORDINANCE AMENDING ORDINANCE NO. 2010-2 ENTITLED AN ORDINANCE PROVIDING FOR THE REGULATION OF ANIMALS, NUISANCES AND BURNING

WHEREAS, pursuant to Section 1-2-1 of the Illinois Municipal Code (65 ILCS 5/1-2-1) the Corporate Authorities of the Village of Chapin, Morgan County, Illinois, have the authority to enact ordinances, rules and regulations to provide for the safety, health, comfort, and welfare of its residents;

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois, find that to promote and provide for the safety, health, comfort, and welfare of Village residents, it is necessary to amend and revise the provisions of Ordinance Number 2010-2 to clarify which animals are prohibited within the Village of Chapin;

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois, find that to promote and provide for the safety, health, comfort, and welfare of Village residents, it is necessary to take immediate action to provide for the humane and expeditious removal of prohibited animals (as defined herein) currently kept and maintained within the corporate limits of the Village; and

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois, find that to promote and provide for the safety, health, comfort, and welfare of Village residents, it is necessary for the amendments to Ordinance Number 2010-2 detailed herein be effective retroactively to the effective date of this ordinance.

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois as follows:

- Section 1. The foregoing recitals are incorporated into this ordinance by this reference as if they had been restated verbatim.
- Section 2. Section 1-3-3 of Ordinance 2010-2 is amended by deleting the current language of said section and inserting the following new language:
  - Section 1-3-3. <u>Prohibition of Specific Animals</u>. It shall be unlawful for any person, entity or organization to keep or maintain within the Village any horse, mule, donkey, goat, sheep, lamb, llama, swine, cattle, fowl, chicken (hen or rooster), goose, duck, wild animal, or a rare and exotic animal.
- Section 3. Article III of Ordinance 2010-2 is amended by the addition of the following new Section 1-3-3-1:
  - Section 1-3-3-1. Compliance with Section 1-3-3. Any person, entity or organization who is keeping or maintaining within the Village any horse, mule, donkey, goat, sheep, lamb, llama, swine, cattle, fowl, chicken (hen or rooster), goose, duck, wild animal, or a rare and exotic animal as of August 13, 2025, shall have until October 13, 2025, to remove the animal or animals from the Village. Failure to remove such animal or animals from the Village by said date shall constitute a violation of this ordinance and shall be enforced in conformance with this Ordinance 2010-2.
- Section 4. Ordinance 2010-2 is amended by the deletion of Section 1-5-3 in its entirety.
- Section 5. This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form. The Village Clerk is directed to publish this Ordinance in pamphlet form.
