Purpose: This rule making amends the types of pilotage assignments subject to the requirement for ten hours rest with the opportunity for eight hours of sleep after completion of an assignment. Puget Sound Pilots (PSP) recently approved several measures to increase dispatching efficiency and pilot availability while observing State mandated rest rules. One of those measures is to allow a pilot to be dispatched to multiple assignments, as long as the combined duration of the assignments does not exceed thirteen hours. The Board adopted these changes via Emergency Rule at the March 17, 2022 Regular Monthly Meeting. This rule making initiative is to consider and codify that change.
