Marquette County, a chartered County of the State of Wisconsin, operator of the Marquette County Fairgrounds and the above owner, agree to this Storage Agreement on the following material terms:

1. County agrees to provide indoor storage for the above-named boat or property.
2. **Owner shall carry fire, hazard and theft insurance on Owner's property, and show proof thereof** to County, which carries no such insurance on privately owned property stored in its facilities. County therefore accepts storage of Owners property at sole risk of Owner and County shall have no liability to Owner for loss of or damage to stored property caused by fire, vandalism, storm, weather or by any other cause or for the theft of Owners property. \_\_\_\_\_ **(Owner initials)**
3. Owner hereby releases and holds harmless County from any and all claims whatsoever which the owner has or may hereafter accrue on account of or in any way growing out of this Storage agreement other than damages as a result of negligence of County.
4. Equipment is accepted for storage by the County on the express representation by the Owner that he/she owns the property stored or is lawfully authorized to store the same.
5. Owner agrees that his/her property will not be released by County until all monies due are paid in full.
6. The term of this Storage Agreement shall be from October 11, 2025 through April 12, 2026. No property shall be accepted for storage prior to the Storage Agreement start date. Owners must remove their property on the dates specified in April 2026 as posted in the pick-up email and fair website to be sent in early 2026. Any property that remains after the advertised pick up dates will be assessed late fees at the rate of \$50 per week. County may remove property left after that date and store the same outside or any other place that suits its convenience.
7. To protect the security of other property stored by County, Owner shall not have access to the property during the term of storage except by permission and as Owner shall be accompanied by an authorized agent or employee of County. Owner shall not perform any mechanical or maintenance work on Owner's property while in storage.
8. For boat storage, Owner is advised to remove from the boat prior to storage all loose equipment and property such as boat gear, which is stored at Owner's sole risk.
9. Owner is responsible for disconnecting all batteries and to keep gas and propane levels at the lowest levels possible.
10. The undersigned representative of the Marquette County Fair Board represents and warrants that he/she is duly authorized to execute this Agreement on behalf of the County.
11. The owner shall not assign this Agreement except upon written consent of the County.
