### Agility Rules

#### **Move up Policy:**

Move-ups must be submitted to the Secretary by Monday, May 03, 2021 at 5:00pm. DOS Move-ups will be allowed.

**Refund Policy:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the show committee. Exhibitors are responsible for being at ring side when it is their turn to run.

#### **Entry Eligibility**

1. Lamé dogs, dogs that appear ill, females in season, and pregnant or lactating females may not compete in this trial.
2. No dog that has any sutures, bandages, adhesive or any other visible material indicative of any medical procedure may compete.
3. Dogs must be 15 months of age on the day of the event.
4. An un-entered dog may not be substituted for an entered dog.

**Crating:** All crating is outside – there is plenty of room for shade tents. Crating out of your car is allowed.

### Awards

Qualifying ribbons will be provided for all qualifying runs. Rosettes will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place in each class. Additional Rosettes for High in Trial, High in Trial - Junior, ACH, UACHX and GRACH title rosette ribbons.

- Bring lots of water for both you and your dog.

- Obstacles shall meet current specifications for agility trials.
- No Show Photographer will be available.
- Masks will be worn when engaging with the any trial official, during walk throughs (walk throughs may be split for smaller groups).
- Social distancing will be required – please maintain 6 feet between you and everyone else!
