


<p>Today, while performing my U.S. Department of Homeland Security / Transportation Security Administration / Federal Air Marshal Service Visual Intermodal Prevention and Response duties in Union Station in front Chopt restaurant at approximately 11:00 AM, [REDACTED] reported to me that a man touched the inside of her left thigh above the knee. The suspect was later identified as [REDACTED]</p> <p>[REDACTED] stated that when she looked down, she saw [REDACTED] holding a smartphone underneath the skirt of her dress.</p> <p>[REDACTED] pointed to and identified [REDACTED] as the suspect.</p> <p>I approached [REDACTED] and asked him to empty his hands, and allow me to place my handcuffs on him. He was compliant.</p> <p>[REDACTED] continued to be physically compliant and walked with me into a closed area near an elevator shaft entrance adjacent to the Main Hall.</p> <p>After I notified Federal Air Marshal [REDACTED] to contact AMTRAK Police Department (APD) and remain with [REDACTED]. I radioed Supervisory Federal Air Marshal John Miller to meet me.</p> <p>APD assumed custody of [REDACTED].</p> <p>After [REDACTED] voluntarily provided APD with an affidavit, I escorted her back to the adjacent U.S. Securities and Exchange Commission building where she is employed as an Attorney Advisor.</p> <p>APD Sergeant Matthew Lindeman stated to me that [REDACTED] was processed for arrest.</p> <p>***END OF REPORT***</p>
