## Appeals Modernization Update

#### Proposed regulations are in VA concurrence

Scheduled for final publication in Federal Register by January 2019

#### VA has ensured congressional reporting requirements are met

- Progress of appeals reform reported to Congress and GAO every 90 days
- January 17, 2018, Senate Veterans Affairs Committee hearing
- January 30, 2018, House Veterans Affairs Committee hearing
- Ongoing GAO engagement on appeals reform

#### Developing Information Technology systems

- Improvements to the Veterans Benefits Management System (VBMS)
- New "Caseflow" applications (i.e. Caseflow Intake)

#### Future Objectives

- Prepare the Secretary to certify that the Agency can fully implement the Appeals Modernization Act by February 2019
- Monitor progress and success of appeals modernization
- Refine processes and best practices to ensure rapid reduction of legacy appeals





## RAMP Update

- RAMP began on November 1, 2017 at the ARC in Washington, DC
- February 2018 VA will expand RAMP processing to ROs
  - Tentatively the Denver and Phoenix ROs to start
  - VA will expand to additional ROs as warranted by opt-in rate and workload capacity
- RAMP Data as of January 25, 2018
  - 431 total appeal count opt-in
  - 225 higher-level reviews and 92 supplemental claims received
  - Average days pending of 27.7 days
  - 88 issues granted; 144 issues denied
  - 27 claims granted; 20 claims denied
  - \$1,254,964.07 awarded for granted benefits

## Board of Veterans' Appeals Update

## The Board is on pace to produce over 81,000 decisions for Veterans this fiscal year

- As of January 22, the Board signed 22,872 decisions
- With 31.0% of the fiscal year lapsed, the Board has achieved 28.2% of its annual goal

#### The Board is developing training and tools to improve decisions

- Training for the new appeals framework will begin in April 2018
- A new decision template, currently in testing, will create efficiencies for decisiondrafting attorneys, assist Veterans Law Judges in their review, and provide Veterans with better, clearer information

#### **Enterprise-wide efforts**

- The Board is working with Digital Service at VA to ensure IT systems will support timely processing of all appeals;
- A dedicated, expert Project Manager from VA's Office of Enterprise Integration is assisting the Board in implementing the new framework and improving the legacy processes
