Per AKC Rules Applying to Dog Shows, Chapter 7, Section 8: All those who have entered dogs to be shown under the advertised judge shall be permitted to withdraw their entries no later than one half-hour prior to the scheduled start of any regular conformation judging at the show, and the entry fees paid for entering such dogs shall be refunded.

DIRECTIONS

From Arizona:

On US-93-95 (I-515) or I-11 Westbound – take I-11 North to Exit 85 for Craig Road and turn West. Proceed for appx ½ mile to Right on Rancho Drive. Proceed for appx 1/3 mile and turn Right into Smarty Paws.

From California:

From I-15 N - Exit 42A for I-11/US 95 North to Exit 85 for Craig Road and turn West. Proceed for appx ½ mile to Right on Rancho Drive. Proceed for appx 1/3 mile and turn Right into Smarty Paws.

From Utah:

From I-15 South – Take Exit 52 for County Rd 215 W, continue for appx 12 miles. Exit 38 A/B for US-95 S toward Las Vegas. Proceed for appx 1 mile and take a slight Right onto the Ann Rd ramp, US 95 becomes Rancho Rd. Go past Craig Rd. Turn Right into Smarty Paws.
