Art league release forms must accompany each entry and can be taped to the back of late entries. A release form is included in this newsletter, and there will be more forms at check-in and later at the Jack Benny Center reception desk.

The six-week show at Waukegan's Jack Benny Center for the Arts will conclude at our Monday, May 21 general meeting in the JBC's theater, where professional artist **Karen Sako** will critique our entries and award ribbons, including Best of Show. The critique and meeting will run from 7:00 to 9:30, and refreshments will be served during a break. This is open to the public.

Plein Air April 28 at Schweikher House, Schaumburg

This plein air is about a modest but striking prairie-style home that initially served as a home and studio for its architect. It's also about an annual plein air competition within the boundaries of Schaumburg. We will photograph, draw and paint the house exterior, a promising mix of bold geometric shapes and lace-like spring vegetation.

An eighth Annual Prairie Plein Air Competition and Show, sponsored by the Village of Schaumburg and its Prairie Center Arts Foundation, coincides with our visit. Contenders must paint any location in Schaumburg between April 27 through May 11. Due to our interest the house has now been identified as a suitable subject Arts Festival May 18

for the competition, so contenders may come and go while we are there. Our artists can certainly enter the competition, but the deadline is April 13 and the entry fee \$30.

This home and studio building was constructed in 1937–38, an experiment conceived by architect Paul Schweikher and his artist wife, Dorothy. Inspired more by Ludwig Mies van der Rohe than Frank Lloyd Wright, the house is now said to have been unique for its time.

In 1953 the Schweikher family moved to Connecticut and Dr. Alexander Langsdorf and his wife lived there for the next sixty years. (Dr. Langsdorf was a physicist who worked under Enrico Fermi at the University of Chicago.) The building and property were ultimately deeded to the village, which established the Schweikher House Preservation Trust. The trust has made this plein air opportunity possible. The entrance is a 500-foot gravel driveway along the right (east) side of Meacham Rd. almost a mile north of Biesterfield Rd. Except for a large rusty mailbox, pictured, there are no signs of any kind to suggest a simple gravel drive leads to something important. At the end of the driveway there is a small area for parking in the courtyard

between the garage and house. If that is full cars must turn in the courtyard and park along the north side of the driveway along the grassed shoulder.

Notice of this event will only be sent to art league members because parking could be easily overwhelmed if we have the kind of big turnout we sometimes get on a pretty day. A plein air reminder will be sent to members a week before the event. Detailed driving instructions will be included, and these are critical because not all GPS networks can reliably get you to this unmarked gravel driveway. The Schweikher House is a bit of a drive from Lake County, taking at least 30-minutes from Mundelein on a Saturday morning.

LCAL to Host Regional Plein Air Gathering August 4

Every two years the Lake County Art League hosts a dawn-to-whenever regional plein air gathering at the Fox River Forest Preserve, and the fourth such meeting is scheduled for Saturday August 4. It's being held to promote plein air, to network, to share stories, successes and frustrations, and to make sales contacts. It is open to the public and the forest preserve will not charge an entrance fee for either residents or non-residents.

A large pavilion has been rented for display and for shelter from the August sun. The cool sunrise session will be an opportunity to work in the special light that photographers call the "golden hour," the period at the very beginning (and end) of the day when daylight is both redder and softer than when the sun is high in the sky.

There are plenty of natural views at the water's edge and in an oak savannah on the east bluff of the river. The forest preserve's boat launch and architecturally designed marina provide almost constant activity on a hot summer's day, and the 170 boat slips are a 1000-foot walk (or a short drive) from the pavilion. The water view there across the undeveloped islands and far shore is worth checking out.
