

**AMELIA VILLAGE, OHIO
ORDINANCE O-2019-24**

**AN ORDINANCE AMENDING THE PAY
FREQUENCY OF ADMINISTRATIVE COORDINATOR
HYDER FROM MONTHLY TO BIWEEKLY
AND DECLARING AN EMERGENCY**

WHEREAS, Amelia Village hired full time administrative coordinator John Hyder by Ordinance # O-2018-43, pursuant to the terms specified therein; and

WHEREAS, Ordinance # O-2018-43, Section III provides that Mr. Hyder's specified salary shall be paid out once a month; and

WHEREAS, Village Council wishes to amend that Ordinance to allow for Mr. Hyder's pay to occur biweekly, with all other terms in # O-2018-43 for his employment with the Village staying as provided for in the Ordinance.

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that:

SECTION I. Council hereby amends Ordinance # O-2018-43 to change the frequency of Mr. Hyder's pay, as administrative coordinator, from monthly to biweekly, with all other provisions of Ordinance # O-2018-43 staying in full force and effect as provided for in the Ordinance.

SECTION II. Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this council, and that all deliberations of the Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III. This Ordinance is hereby declared an emergency which is necessary for the preservation of the public health, safety, and general welfare. The reason for such necessity is to provide for Mr. Hyder's pay to be adjusted as soon as possible to the biweekly pay structure before the next soonest biweekly pay period. This appointment will allow the Village to provide necessary uninterrupted administrative services to the citizens of the Village. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

MR. HACKER moved to suspend the rules requiring two readings on two separate dates.

MR. FISCHER seconded the motion.
