**FEE STRUCTURE:**

Bollywood dance lessons : S\$ 100.00(Sing dollars one hundred per month) ,plus one time registration fee as applicable, starting from the 1<sup>st</sup> dance class of the month to the last dance class day of the month. Classes will be held once in a week, basis four classes a month. The classes are not based on the number of weeks in a calendar month. Fees will be prorated for joiners commencing classes in between the 1<sup>st</sup> and the last class days. There will be no refund for termination of classes by the student. In case the company terminates lessons for any student, the remaining prorated fees will be reimbursed. There will be no credits for missing classes, except(i) on production of medical certificate from a recognized medical practitioner in Singapore and/ or(ii) copy of the overseas travel ticket to and from Singapore. The dance class schedule does not follow any school calendar.

**WITHDRAWAL :**

One month notice is to be given in case of withdrawals.If the required notice is not given ,the Academy reserves the right to collect one month fees.

**PAYMENT:**

Fees are to be paid for the full month on the 1<sup>st</sup> class day of the month, in cash. There are no refunds for the student being from the class except as mentioned in the 'fee structure' Para above.

**GENERAL:**

Please ensure your child/ward or the student arrives at least five minutes before the scheduled start up time of the class. Please ensure that he/she/you are dresses in comfortable attire for the dance lessons. Please ensure that he/she/you carries a water bottle with safe drinking water. Parent observance is encouraged. Viewing must be through the viewing windows: not from within the class room. During the sessions, none other than the instructor and the students will be allowed to be inside the class room. Instructors might from time to time invite parents/guardians inside for specific discussions or for a quick show to see how their child/ward is performing. This is entirely up to the instructor's discretion. Please do not allow children to use the hall, passage ways and other halls as play room, day care or babysitting rooms. Kindly ensure that students are received promptly at the end of each class. Should a self organized class group wishes to cancel a particular class, please advice the instructor at least three hours before the scheduled time. The company has the option to perform at events/functions. The student may be inducted to take part to display their talent. The costumes will be charged at the actual cost. Company recommends the sufficient medical and /or insurance cover is in place for the student. Company does not insure the students nor will be liable for any claims whatsoever. The Company has the rights on the photographs taken during its activities for use in its publicity materials, brochures etc. Use of such photographs by anyone else without written consent of the Company will not be allowed.
