Article I

<u>To Choose a Moderator</u>: A motion was made and seconded to nominate Glenn Dearth as Moderator.

Article II

<u>To Hear and Act on the Report of the Water Commissioners</u>: A motion was made and seconded to accept the Commissioners' Report as printed on page 4 of the 2024 Annual Report.

Article II was carried by unanimous vote in the affirmative to accept the 2024 Commissioners' Report.

Article III

<u>To Elect a Water Commissioner for Three Years</u>: Jason Kauppi was nominated and seconded to serve as Water Commissioner for three (3) years. As there were no other nominations, by acclamation, the <u>Vote</u> was unanimous in the affirmative, and Jason Kauppi was elected to serve as Water Commissioner for three years.

Article IV

To Appropriate Such Sums of Money as May be Necessary to Defray the Expenses of the District for the Ensuing Year (FY 2026), and to Act on the Budget of \$1,048,435.08 of the Water Commissioners. A Motion was made and seconded to vote on the budget as printed on page 5 of the Annual Report in the amount of \$1,048,435.08.
