The Village of Russells Point, Ohio (the "Village") has been asked to consider approving property assessed clean energy ("PACE") financing for a to-be-constructed Cobblestone Hotel and Suites within the boundaries of the Village.

The owner of the real property to be assessed, Indian Lake Hotel Group, LLC (the "Owner") has submitted a Petition for Special Assessments for Special Energy Improvement Projects (the "Petition") to the Village. In the Petition, the Owner provided a description of the PACE improvements to be installed at the site and requested that the Village levy 56 semi-annual special assessment installments in the amount of \$62,183.50 each.

In order for the Village to approve the PACE financing and levy the assessments, the Village Council has been asked to consider the following three pieces of legislation in the following order:
