

**AMELIA VILLAGE, OHIO**  
**Ordinance O-2013-26**

**AN ORDINANCE AUTHORIZING THE DISPOSITION OF PERSONAL PROPERTY  
NOT NEEDED FOR MUNICIPAL PURPOSES AND DECLARING AN EMERGENCY.**

**WHEREAS**, Revised Code Section 721.15 provides for Amelia Village to dispose of personal property which is unneeded, obsolete or unfit for municipal purposes; and

**WHEREAS**, said Section further provides that upon authorization of Council, and upon approval by the officer, board or manager having supervision over the same, said property, said property shall be sold to the highest and best bidder; and

**WHEREAS**, the Village, having previously adopted Resolution No. R-2013-07, is permitted to sell personal property, which is not needed for public uses, or is obsolete or unfit for the use for which it was acquired, by internet auction;

**NOW, THEREFORE**, be it ordained by Council of Amelia Village, Ohio that:

**SECTION I:** Village Council does hereby authorize the sale of various items of personal property of the Village, which are no longer needed for municipal purposes, by auction in a manner authorized by Revised Code Section 721.15, said items are shown on the attached Exhibit A and incorporated herein.

**SECTION II:** The Mayor and the Fiscal Officer are hereby authorized and directed to take any and all actions necessary to complete the auction of the unneeded personal property of the Village.

**SECTION III:** That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village, and for the further reason that it is immediately necessary to approve this at the earliest possible time, in order that the Village may receive the auction proceeds at the earliest possible time. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

**SECTION IV:** Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

KATIE KRAFKA moved to suspend the rules requiring three readings on three separate dates.


