- 3. Balderstone Hall Lane Cllr Benson explains SUDS in relation to the proposed development. He states that the developer will use SUDS as the cheapest option. He states that he is concerned who will look after SUDS once the development is built. He uses the McInerney development as an example of bad land drainage. He states that Yorkshire Water accepted the design of the drainage in principal but never approved it. He states in his opinion, if a management company is appointed by the developers at Balderstone, the land drainage will be wrong. He would like to investigate further and send any information via the Clerk to R Halstead. Cllr Lees-Hamilton asks Cllr Benson to send any information he has to the Clerk, so that this can be circulated.

 Asset of Community Value – Cllr Lees-Hamilton reads the minutes from October 2013 MTC119 (4) & MTC132 (4) nominations for Community Right to Bid. Cllr Guy thanked Cllrs J & K Taylor for helping to set up Friends of Mirfield Library. Cllr Guy explains that rather than just submit an online petition, people should be encouraged to use the library, as active users bode better than just a petition, he states the user figures are calculated from the date of request to 12 months prior, therefore if residents become members now, the figures will count. Cllr Lees-Hamilton confirms that Roger & Alma have the latest user figures. Cllr Lees-Hamilton states that the Cllr who was researching Community Right to Bid scheme is no longer a member of Mirfield Town Council. Cllr Pinder **Proposed** that the list MTC132 (4) be sent to Kirklees to note as Assets of Community Value Cllr Armitage Seconded Vote: All in favour secondly Cllr Pinder Proposed that he look into a Town Square concept including Black Bull Building, Natwest, Former Post Office Building, Salvation Army Building, Former Vale cinema, Trinity Church, Library Garden, Former Eastthorpe School & Gardens, Speights Lighting Building and Council Offices and investigate having this area classified as a Town Square/Area of Importance to the town Cllr K Taylor Seconded Vote: All in favour

Budget Proposals (All Cllrs have a copy of the Budget Proposal) Cllr Lees-Hamilton states that she is proud Mirfield Town Council will not be increasing the precept for Mirfield Residents, despite the fact that MTC have taken over the management and maintenance of the Public Toilets and only receive £1000 festive lighting grant from Kirklees in excess of the precept. This amount is a sixth of the actual cost for the Christmas Lights. She states that Mirfield Christmas Lights Switch On provides an excellent evening of entertainment for the residents. She concludes that MTC are managing their budget better than Kirklees do theirs, MTC is running leaner and more efficient than Kirklees. Cllr Pinder Proposed to accept the budget and columns Cllr Guy Seconded Vote: All in favour

Use of premises for May Election Cllr Lees-Hamilton Proposed that in the interest of the residents of Mirfield to have a central polling station, Kirklees may use the building on 7th May 2015, but election staff must leave the building in the way it was found, unlike last year or MTC will reserve the right to charge Kirklees accordingly for the cleaning of the building Cllr Pinder Seconded Vote: All in favour Cllr J Taylor Proposed that the New Council in May upholds this recommendation Cllr K Taylor Seconded Vote: All in favour

Cllr Nottingham informs MTC that there will be a Towpath Clearing event on Saturday 14th March 10.00am at Shepley Marina with Canal & River Trust & Community Payback.

Cllr J Taylor reads an email sent from Cllr Bolt regarding Mirfield Railway Station and Cllr Pinder updates MTC in his absence. He states that WYCA declared Kirklees thought Ravensthorpe Station to be a priority; however statistics prove Mirfield is third in the area with users, behind Huddersfield & Dewsbury. Possible changes are to remove the central platform and possibly acquire the Builders Merchants land, which would give a disabled access and be better for electrification. Possibly looking into a land swap with the builders merchants before the tenancy runs out. WYCA are also looking at additional parking ASAP using the land adjacent to the existing parking and possible new frontage with disabled access, café and newsagents. He states the environment agency are looking at reclassifying flood plains and if so there may be a possibility that land south of the station be used for car parking. He concludes by saying that it was a very constructive meeting with all agencies in favour of Mirfield Railway Station. Cllr Lees-Hamilton **Proposed** to write to Secretary of Transport and invite him to a meeting with MTC and Friends of Mirfield Railway Station Cllr Pinder Seconded Vote: All in favour

Cllr Lees-Hamilton reads a letter from Towns Women Guild in support of MTC retaining the Council Offices Cllr Lees-Hamilton **Proposed** MTC write and ask them if MTC may forward this letter to Kirklees, S Reevell and the press Cllr Pinder **Seconded Vote:** All in favour
