LEGAL

Attorney Williams had no updates.

POLICE CHIEF MARK THOMS

Chief Thoms spoke on the following:

- 9,966 calls in 2020; majority were property checks and citizens assist.
- 2 Officers attended Evidence Photography training.
- All officers are required to attend Implicit Bias Training on select dates in January and February. Officers are required to watch videos, complete readings and assessments before attending the training. Training takes place at Finger Lakes Community College or Canandaigua PD.
- Schedule a meeting with Personal Committee to review Sr. Clerk applications.
- 8 out of 14 police officers wanted the COVID-19 vaccine and have received their first shot.

Motion Trustee Bendix, seconded Trustee Blodget and carried unanimously to send the 2007 Jeep Grand Cherokee and 2008 Chevrolet Tahoe plus numerous tires to surplus auction once GPS device has been removed from vehicles. The vehicles are no longer in use and have been repaired numerous times for miscellaneous issues. The tires were surpluses that came off three new patrol vehicles that we put All Season tires on.

SUPERINTEN-DENT DPW BOB HUTTEMAN

Superintendent Hutteman spoke on the following:

- 18 Salt/plow runs to date.
- Calibrated trucks to regulate the salt.
- In the process of removing dead trees from Ross Park.
- Transmission lines from our reservoirs to our WTP in Manchester have been walked. No immediate work needed. Some tree removal will be needed in the future.
- Repairs at St. Mark's for a Village end sewer issue.
- Repairs at the Library for furnace issues.
- Completed railroad repair.
- Sign Inventory are in process. Reviewing signs for replacement.
- Discussion about light fixtures currently not working.
- Training for Class D, Safety and OSHA in process.

TRUSTEES

Trustee Howard thanked former Village of Newark Trustee Rebecca Vermeulen for writing the Erie Canalway Heritage Corridor Grant for \$1,500.00, which the Village was previously awarded in December 2020.
