### **Financial Overview**

- The Parking Authority had YTD revenue as of April 30, 2025 of \$254,042. This is \$1,675 higher than the previous year. Total YTD expenses were \$138,702. A decrease of \$12,720 compared to the previous year. Net YTD revenue was \$115,340. An increase of \$14,396 compared to 2024.
- The Park and Ride had YTD revenue as of April 30, 2025 of 88,890. This is \$4,135 higher than the previous year. Total YTD expenses were \$68,404. A decrease of \$695 compared to the previous year. Net YTD revenue was \$20,489. An increase of \$4,833 compared to 2024.
