

ORDINANCE NUMBER 97-39

AN ORDINANCE OF THE TOWNSHIP OF MARION, CENTRE COUNTY, PENNSYLVANIA, ESTABLISHING THE ANNUAL COMPENSATION FOR SUPERVISORS OF MARION TOWNSHIP BY INCREASING THE SALARIES OF SUPERVISORS FROM FIFTY DOLLARS (\$50.00) PER MEETING TO AN ANNUAL MAXIMUM COMPENSATION OF EIGHTEEN HUNDRED SEVENTY-FIVE DOLLARS (\$1,875.00) AND PROVIDING FOR THE PAYMENT OF SAID COMPENSATION ON A MONTHLY BASIS.

Be it enacted and ordained by authority of the Supervisors of Marion Township, Centre County, Pennsylvania, and it is hereby enacted and ordained by authority of the same as follows:

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania previously enacted 53 P.S. 65606 amended the Second Class Township Code setting forth certain guidelines and limitations for the compensation of Supervisors of townships of the Second Class; and

WHEREAS, this Act provides that Supervisors of Townships having a population not exceeding 4,999 shall be compensated in an amount not to exceed Eighteen Hundred Seventy-Five Dollars (\$1,875.00) per year; and

WHEREAS, the population of Marion Township is less than 4,999; and

WHEREAS, said Act of the General Assembly authorizes the Boards of Supervisors of various townships of the Second Class to determine the compensation of Supervisors subject to the limitations set forth in said Act; and

WHEREAS, pursuant thereto the Supervisors of Marion Township previously established the salary for Supervisors at the rate of Fifteen Hundred Dollars (\$1,500.00) per year; and

WHEREAS, the Supervisors now determine to increase the compensations for Supervisors on an annual salary basis of Eighteen Hundred Seventy-Five Dollars (\$1,875.00) per year, which increase will become effective as the term of each current Supervisor ends.

NOW, THEREFORE, pursuant to the authority vested in the Township Supervisors of Marion Township pursuant to 53 P.S. 65606, it is hereby enacted and ordained by the Authority as follows:

**Section One:**

Each Supervisor of Marion Township elected or appointed to office with term beginning on January 1, 1998, shall receive compensation as such Supervisor in the amount of Eighteen Hundred Seventy-Five Dollars (\$1,875.00) per annum.

**Section Two:**

The compensation authorized under this Ordinance shall be paid monthly, for each supervisor.

**Section Three:**

The effective date of this increase will be January 1, 1998 for the term of any and all Supervisors whose terms commence on or after the effective date.

**Section Four:**

The Ordinance repeals all previous Ordinances inconsistent herewith.

**ENACTED AND ORDAINED** as an Ordinance of the Township of Marion this 14th day of October, 1997.
