THESE CHARITABLE IRA TRANSFERS ARE NOT TAXED AND COUNT TOWARDS THE ANNUAL REQUIRED MINIMUM DISTRIBUTION.
- 3) CONSIDER GIFTS OF LIFE INSURANCE. MANY PEOPLE HAVE LIFE INSURANCE POLICIES THAT THEY TOOK OUT YEARS AGO FOR A SPECIFIC PURPOSE BUT ARE NO LONGER NEEDED TODAY. IN THOSE INSTANCES YOU MAY APPOINT A CHARITABLE INTEREST AS BENEFICIARY OF AN EXISTING POLICY OR YOU MAY DECIDE TO MAKE A GIFT OF THE POLICY BY GIVING ALL RIGHTS AND BENEFITS TO THE ORGANIZATION. YOU MIGHT ALSO WISH TO MAKE A GIFT OF A NEW POLICY FOR CHARITABLE PURPOSES. THIS IS AN EASY WAY TO MAKE A LARGER GIFT OVER TIME.
