New Business: Mr. Marcho made a motion to appoint Dick Vautor, Road Master at the rate of \$15.00 an hour. Seconded by Mr. Searle. All in favor. With a review in three months.

Mr. Marcho made a motion to assist in the subdivision and buy the Tell property at the appraised price of \$7500.00 per acer or less with the Act 13 money. Seconded by Mr. Searle. All in favor. Mr. Marcho also made a motion to have Sandy Wilmot apply for a grant to pay half the cost of the property by DCNR. Seconded by Mr. Searle. All in favor.

Parks and Recreation: Getting ready to start the bathroom project and did some work on the multi-purpose court. They are discussing the pavilion and hope to get it done by the end of the summer.

Tax Collector: Mrs. Price reported that all the tax bills have gone out. Mr. Phillips is helping her quite a bit.

Fire Company: Mr. Phillips reported 13 fire incidents in February, no numbers for the ambulance.

Historical Society: Mrs. Wilmot reported the general store in the museum is done and in the hall the soldier (Owen Phillips) display is almost done.
